FIS 21-139 Department of Health and Human Services – Kerrin Rounds, Chief Financial Officer, Deborah Scheetz, Director, Long Term Supports and Services, Katja Fox, Director, Division for Behavioral Health, Heather Moquin, Chief Executive Officer, NH Hospital, Henry Lipman, Director of Medicaid, Division of Medicaid Services, and Joseph Caristi, Chief Financial Officer, NH Hospital, Department of Health and Human Services responded to questions of the Committee regarding; 1) the Psychiatric Long Term Care and Assisted Living Expansion, specifically the availability of additional beds in the long-term care facilities without impacting the normal long term care needs, and 2) Expansion of Transitional Housing Scope of Services at the PATH Center, which increases staffing necessary to serve individuals with more complex needs but does not add new beds. The Committee also inquired as to what progress was being made for an increase in beds for Designated Receiving Facilities for Psychiatric Care Expansion for Adults; following up with questions regarding Psychiatric Care Expansion for Children; and the Department's plan for returning to Fiscal for Homeless Shelter Rate Increases.

The Department added, for the record, a point of clarification on #1 that the special case rate per diem is paid out of the Medicaid budget, if they are Medicaid eligible.

accept and expend federal funds in the amount of \$13,137,051 from the American Rescue Plan Act (ARPA) to fund improvements in New Hampshire's mental health system, as outlined in Executive Order 2021-09, effective retroactive to May 17, 2021 through June 30, 2023.

Taylor Caswell, Commissioner, Department of Business and Economic Affairs, responded to questions of the Committee.
