REQUESTED ACTIONS

- 1. Pursuant to RSA 14:30-a, VI, authorize the Department of Environmental Services (NHDES) to accept and expend \$100,000,000 in federal funds from the American Rescue Plan Act of 2021 (ARPA) to fund investments in drinking water and wastewater infrastructure, effective upon Fiscal Committee and Governor & Council approval through June 30, 2023. This is an allowable use of ARPA FRF funds under Section 602 (c)(1)(D) for water and sewer infrastructure as well as Section 602 (c)(1)(C) for provision of government services to the extent of the reduction in revenue. Funding is 100% Federal Funds.
- 2. Pursuant to the provisions of RSA 124:15,I, authorize NHDES to establish one full time temporary position effective upon Fiscal Committee and Governor & Council approval through June 30, 2023. The position was approved by the Division of Personnel on April 29, 2021. A copy of the approval documentation is attached.

EXPLANATION

The American Rescue Plan Act (ARPA) of 2021, is a \$1.9 trillion economic stimulus bill passed by the 117th United States Congress and signed into law by President Biden on March 11, 2021, to speed up the United States' recovery from the economic and health effects of the COVID-19 pandemic and the ongoing recession.

The Act defines eligible uses of the state and local funding, including responding to public health emergency, responding to workers performing essential work during the COVID -19 emergency, providing revenue relief to states and making investments in water, sewer and broadband infrastructure.

Based on planning between the Department, legislative leadership, and the Governor's Office, a portion of the ARPA funds was initially allocated to NHDES to invest in the drinking water and wastewater infrastructure of New Hampshire. The initial \$50 million appropriation was approved by the Fiscal Committee on June 8, 2021, Item #21-138 and by Governor & Council on June 16, 2021, Item #101, allowing NHDES to stand up the program by having the necessary initial staff in place to begin managing the infrastructure program and begin to award grant funding to entities. It was anticipated at the time that as additional ARPA funds were allocated to NHDES additional full time temporary positions would be established to meet the new, increased responsibilities. Given the magnitude of the funds being awarded for major drinking water and wastewater infrastructure projects, these responsibilities are significant, and include administering these funds as grants, with extensive financial and compliance monitoring being placed on NHDES to comply with federal transparency requirements.

Based on further planning between the Department, legislative leadership, and the Governor's Office NHDES is continuing to develop a detailed use plan for the additional ARPA funds based on interim guidance from the US Treasury Department.

NHDES is requesting to budget these additional funds as shown below:

Class 040	To cover the program share of statewide indirect costs.
Class 041	To cover the cost of Audit Set-Aside charges related to the federal program.
Class 042	To cover the program share of additional fringe benefit costs.
Class 049	To cover transfers to other State Agencies.
Class 059	To cover the costs for the one full-time temporary position for coordination and execution of NHDES's management of investments in drinking and clean water infrastructure projects.

The following is intended to address the seven questions required by the Fiscal Committee with respect to the acceptance of federal and other funds in which new positions are established or extended:

- 1. List All Personnel by Classification, Labor Grade, and Salary: One fulltime, temporary position as listed below:
 - Environmentalist IV (LG 27, \$56,218 \$80,106) to supervise environmental program activities associated with public water system sustainability to promote maintenance, improvement and resilience of public water system infrastructure as associated with ARPA projects. Responsibilities include ensuring availability of broad funding options, processing funding actions, supervising review of applications, managing drinking water projects, review of reimbursement requests for payments, and assisting with federal reporting requirements such as Davis Bacon, American Iron and Steel and Minority and Women's Business Enterprise in order to ensure the proper and timely reporting of ARPA funding recipients.
- 2. Explain the Nature, Need, and Duration of the Program: The American Rescue Plan Act of 2021 is providing funds to states through the Coronavirus State Fiscal Recovery Fund to assist states with the economic impacts of the pandemic. To this end, this portion of those funds is earmarked for water and sewer infrastructure improvement investments. The program runs through December 31, 2024 for obligating the funds and through December 31, 2026 for expending the funds.
- 3. What is the Relationship to Existing Programs?

The ARPA funds will complement the existing Clean Water and Drinking Water State Revolving Fund programs as well as the Drinking Water/Ground Water Trust Fund in providing grants/loans for water and sewer infrastructure improvements.

- 4. Has a Substantially Similar Program been Requested of the Legislature and Denied? No.
- 5. Why was this Program and Its Funding Not Included in the Operating Budget? The federal grant funds were not available at the time the department created its FY22/23 Operating budget request. Management of the overall ARPA funds is being coordinated through GOFERR.
- 6. Can any Portion of the Funds Be Utilized if Either, None, or Only Part of the Positions are

Authorized? No, the contracts, loans and grant portions of the requested funding could not be effectively awarded without approval of the position. Current staff resources would preclude timely review and processing of work scope authorizations, reports, engineering plans and loan/grant applications. Current staffing is not sufficient to allow timely execution of the work required under the federal requirements.

7. What is the Estimate of the Amount of Funding Required to Continue the Positions in Future Years? It is anticipated that the position is likely to continue until the ARPA funding expires on December 31, 2026. The estimated cost of this position in FY 24/25 is \$177,740 and FY 26/27 is \$137,304.

EXPLANATION

Hampstead Hospital has served an important role as New Hampshire has adapted its behavioral health system to meet population needs across the lifespan. This includes moving pediatric services outside of the New Hampshire Hospital campus to ensure appropriate focus on child-specific treatment needs while allowing more treatment and space options for transitional and supported housing for New Hampshire Hospital's adult patients. Through its contract with DHHS, Hampstead Hospital has been an important partner in addressing the needs of children.

This unique opportunity to purchase Hampstead Hospital comes at a time when children's and families' needs to access mental health services has increased significantly. COVID-19 has exacerbated many children's behavioral health issues. During the pandemic, a number of children who had never been involved in the mental health system experienced high levels of distress, leading their families and providers on a difficult search for pediatric acute and inpatient care.

The size and structure of the facility and surrounding lands would allow the State to expand bed capacity to meet the growing needs of New Hampshire youth. This expansion would include providing local care for children who are currently receiving state-funded services outside of NH. When care is provided to children in-state, it can make it easier to transition them to community-based services upon discharge to continue their care.

Inpatient services for children and youth are part of New Hampshire's commitment to fully implementing the Children's System of Care, which spans the needs across the continuum, from community-based services to psychiatric hospitalization. The new system has a number of components, including: screening and assessments; mobile crisis response; community-based treatment, care and support; intensive home services; and residential treatment. While the new services are designed to address needs in the community whenever possible, the system still needs to have capacity to provide acute services.

In addition to helping immediately address the urgent behavioral health needs of New Hampshire youth and families, the purchase of Hampstead Hospital makes good fiscal sense for the State. Following extensive negotiations, the purchase price for the real estate is significantly lower than the appraised value of the parcel conducted in 2016. Furthermore, it is reasonably expected that the value has increased since the time of the report given the sharp increase in overall real estate values across the State. In addition, the estimated cost of purchasing an existing facility is dramatically lower than the construction of a new facility. Building a new facility is not only the more expensive option, but is one that would take years to complete.

In sum, purchasing this existing facility is the most efficient and effective way to increase behavioral health services capacity while supporting future lives of stability, well-being, and independence for New Hampshire's youngest residents.

The State will be assuming the accounts receivable and accounts payable at the time of purchase. An appropriation is needed to manage these prior accounts until they are closed out. It is expected that accounts receivable will end up exceeding accounts payable and the ARPA funds will not be required.

Class 085-588514, Inter-Agency Transfers out of Federal Funds

These funds will be paid to the Department of Administrative Services to conduct a property line boundary survey of the following three parcels currently owned by Hampstead Hospital and identified as Map 13 Lot 3 (89.88 acres), Map 13 Lot 128 (2.04 acres), and Map 13 Lot 129 (2.49 acres). The project will be phased into two efforts. The first phase will include a full property line boundary survey plan which will include dimensional zoning, FEMA zone identification, wetlands based off of the National Wetland Inventory (NWI) website, and LiDAR topography from the Statewide LiDAR inventory. The second phase which is not included in this cost estimate is aerial mapping and wetland site assessment and demarcation. Additionally, this class line will fund completing a topography and features description.

Class 103-502507, Contracts for Operational Services

These funds are to pay for the appraisal report provided to the Department that detailed the value of the Hampstead Hospital business and to enable the Department to fully evaluate options for the State to expand critically needed services for patients with psychiatric and chemical dependency needs. The Department used the report to determine a price at which the Hampstead Hospital business would change hands between a hypothetical willing and able buyer and a hypothetical willing and able seller in an open and unrestricted market. In completing the appraisal report, the Contractor also considered other relevant limitations impacting the healthcare setting, as applicable, including the impact of the COVID-19 pandemic on the economy and other related healthcare market factors. Additionally, these funds are to pay for the Phase I Environmental Site Assessment of the Hampstead property.

This item does not include any funding for operating the facility. A separate item will be presented for the operating budget. In order to design an effective and appropriate operating budget for the facility, the Department is actively reviewing financial reports, Medicare Cost Reports, contract needs, and general operating requirements. As the facility was not state-run previously, there are many implications relative to state finance and procurement law that must be considered, and as such the Department is working diligently to resolve these questions and be able to bring forth an operating budget for the facility.

EXPLANATION

The Department is requesting to accept and expend American Rescue Plan Act (ARPA) funding to support safe and effective COVID-19 vaccine delivery within Federally Qualified Health Centers (FQHCs) and voluntary school and/or community based clinics. There is ongoing need to make vaccination opportunities available to people in New Hampshire who make the choice to get vaccinated. Although the COVID-19 vaccine is still effective against severe disease and death, booster shots are now available for certain individuals who are medically vulnerable or who have other risk factors.

Cases of COVID-19 are increasing among children and many parents are interested in vaccinating their children to help prevent illness and transmission of disease. These funds will support Regional Public Health Networks (RHPNs) to set up efficient vaccine clinics throughout the state to improve access for individuals and caregivers who wish to have their children vaccinated. School-based and community clinics relieve the burden on an already stressed health care system.

FQHCs integrate access to primary care, pharmacy, mental health, substance use disorder, and oral health services in areas where economic, geographic, or cultural barriers limit access to affordable health care. They are well-prepared to answer questions and deliver vaccine to low income individuals and their children. Both FQHCs and RHPNs can provide familiar and convenient locations for working families to get vaccinated.

Funds will be used for vaccine delivery and logistics and will not be used to support the development or enhancement of the Immunization Information System (IIS).

The funds are to be budgeted as follows:

In summary, additional funding is requested to improve access to COVIID-19 vaccine, especially for children and individuals with medical and other risk factors. The Source of Funds is 100% Federal Funds. This is an allowable use of ARPA State Fiscal Recovery Funds under Section 602(c)(1)(a), to respond to the public health emergency or its negative economic impacts.

In the event that these Federal Funds become no longer available, General Funds will not be requested to support this program.

Dear Representative Umberger and Members of the Committee:

Last week, the Executive Council voted to reject \$27 Million in federal public health funds from the Centers for Disease Control and Prevention (CDC) out of concerns that limited boilerplate language somehow waived the State's ability to continue to fight COVID-19 in a way that is best for Granite Staters as determined by the State. To the contrary, the rejection of these funds will actually limit the State's ability to continue to control how vaccines are provided in our State.

For example, by limiting the State's ability to invest in its vaccine data system means the State will not have the capacity to collect aggregated data on the State's vaccination rate, or who has received a booster vaccine. That means that the State will be limited to relying on federal CDC data instead of its own.

Further, absent robust New Hampshire data, the Department of Health and Human Services (DHHS) will be limited in its understanding of vaccine breakthrough cases. Healthcare providers will have incomplete information to make medical decisions with their patients. The public will not have easy access to their medical records. Policy makers and DHHS will have to further depend on federal CDC data and will be unable to verify information with our own New Hampshire data.

Not only will the State have to look to federal data sources in order to continue its evidence-based approach to pandemic response, this action is cutting off resources for providing vaccines across the State. New Hampshire planned to use funds to support vaccine clinics and to support the operational logistics of supplying vaccine – basic items such as dry ice, shipping containers, postage, and the ability for staff to do required monitoring of clinics.

As of November 2021, it is anticipated that the approximately 125,000 New Hampshire children age 5-11 will become eligible for COVID-19 Vaccine. In addition, as more vaccines are approved for booster doses, providers could be faced with hundreds of thousands of New Hampshire residents seeking vaccines, with little or no support.

In an effort to address some of these challenges, DHHS has submitted a late item to the Fiscal Committee to approve \$4.7 million in ARP State Recovery funds to support COVID-19 vaccine delivery within Federally Qualified Health Centers and voluntary school based clinics. This funding is critical to ensure boosters are available to the State's vulnerable and at risk populations. Cases of COVID-19 are

increasing among children and many parents are interested in vaccinating their children to help prevent illness and transmission of disease.

These funds will support Regional Public Health Networks (RHPNs) to set up efficient vaccine clinics throughout the state to improve access for individuals and caregivers who wish to have their children vaccinated. FQHCs and RPHNs provide familiar and convenient locations for working families to get themselves and their children vaccinated. School-based and community clinics relieve the burden on an already stressed health care system.

This unfortunately means the State is left only with the option to use more flexible funding, while sending back New Hampshire's allocation from the CDC.

As we face the task of providing primary doses for children and booster shots over the next twelve months, DHHS will have addition critical needs beyond this request for \$4.7 million, to support the healthcare community. Vaccine must be shipped, hospitals and healthcare practices unaffiliated with hospital systems need support for vaccine delivery, DHHS staff need to visit each vaccine provider for federally required inspections, and DPHS has continued needs for temporary staff and overtime. Those costs exceed \$7.165 million over the next 12 months:

Without these funds, state run vaccine operations will come to a halt, leaving Granite Staters to rely on federal vaccination efforts. As a first step, we urge you to approve the requested authorization by the Department of Health and Humans Services tomorrow. Thank you.
