## RSA 14:30-a, VI FISCAL COMMITTEE APPROVAL REQUIRED FOR ACCEPTANCE AND EXPENDITURE OF FUNDS OVER \$100,000 FROM ANY NON-STATE SOURCE: CONSENT CALENDAR

On a motion by Senator D'Allesandro, seconded by Senator Daniels, that the Committee approve the requests under this section as submitted. MOTION ADOPTED. [FIS 17-094 Department of Education – authorization to accept and expend \$2,093,372 in federal funds through June 30, 2017, FIS 17-101 Office of Professional Licensure and Certification – authorization to amend FIS 16-055, approved March 18, 2016, by reallocating \$3,000 in other funds through June 30, 2017, FIS 17-103 Department of Environmental Services – authorization to amend FIS 13-246, originally approved November 22, 1013 and subsequently amended by; FIS 15-117 (July 29, 2015) and FIS 15-239 (December 18, 2015), by reallocating \$70,000 in MTBE Settlement funds through June 30, 2017, and FIS 17-104 Department of Environmental Services – authorization to amend FIS 16-141, approved October 14, 2016, by reallocating \$2,486 in federal funds through June 30, 2017]

On a motion by Representative Eaton, seconded by Senator D'Allesandro that the Committee approve the request of the Department of Transportation to reclassify Position #20222 from Civil Engineer VII, LG 34, to Transportation Operations Administrator, LG 35, in the Department of Transportation, Division of Operations, Bureau of Highway Maintenance. MOTION ADOPTED.

### RSA 228:69, I (b), APPROPRIATION AND USE OF SPECIAL RAILROAD FUND:

<u>FIS 17-098 Department of Transportation</u> – On a motion by Representative Eaton, seconded by Representative Ober, that the Committee approve the request of the Department of Transportation to enter into agreements with Railroad Operators, for an amount not to exceed \$900,000 from the Special Railroad Fund for the maintenance and repair of State-owned railroad lines for the period of July 1, 2017 through June 30, 2019. MOTION ADOPTED.

### CHAPTER 275:4, LAWS OF 2015, LOTTERY COMMISSION; AUTHORITY GRANTED:

<u>FIS 17-105 New Hampshire Lottery Commission</u> – On a motion by Representative Ober, seconded by Senator D'Allesandro that the Committee approve the request of the New Hampshire Lottery Commission to; (1) transfer \$2,645,000 from the Lottery Special Revenue Account for the purchase of instant tickets and related services through June 30, 2017. MOTION ADOPTED.

## CHAPTER 276:29, LAWS OF 2015, DEPARTMENT OF TRANSPORTATION; TRANSFER OF FUNDS:

<u>FIS 17-096 Department of Transportation</u> – On a motion by Senator D'Allesandro, seconded by Representative Eaton, that the Committee approve the request of the Department of Transportation to transfer \$2,000 in highway funds between various accounts and classes through June 30, 2017. MOTION ADOPTED.

<u>FIS 17-097 Department of Transportation</u> — On a motion by Representative Eaton, seconded by Senator Daniels, that the Committee approve the request of the Department of Transportation to transfer \$3,000 in federal funds between various accounts and classes through June 30, 2017. MOTION ADOPTED.

CHAPTER 276:143, LAWS OF 2015, DEPARTMENT OF HEALTH AND HUMAN SERVICES; TRANSFER AMONG ACCOUNTS AND RSA 14:30-a, VI FISCAL COMMITTEE APPROVAL REQUIRED FOR ACCEPTANCE AND EXPENDITURE OF FUNDS OVER \$100,000 FROM ANY NON-STATE SOURCE:

FIS 17-102 Department of Health and Human Services – On a motion by Senator D'Allesandro, seconded by Senator Birdsell, that the Committee approve the request of the Department of Health and Human Services to transfer \$2,245,092 in general funds, and increase federal revenues in the amount of \$4,275,800 and increase related other revenues in the amount of \$2,531,173 through June 30, 2017. MOTION ADOPTED.

### CHAPTER 276:198, LAWS OF 2015, DEPARTMENT OF SAFETY; TRANSFER AMONG ACCOUNTS:

FIS 17-099 Department of Safety – On a motion by Representative Eaton, seconded by Senator Daniels, that the Committee approve the request of the Department of Safety to transfer \$35,400 in other funds among Driver Licensing and Credit Card Fees through June 30, 2017. MOTION ADOPTED.

### CHAPTER 276:219, LAWS OF 2015, DEPARTMENT OF CORRECTIONS; TRANSFERS:

<u>FIS 17-100 Department of Corrections</u> – On a motion by Representative Ober, seconded by Senator Birdsell, that the Committee approve the request of the Department of Corrections to transfer \$513,000 in general funds among accounts through June 30, 2017. MOTION ADOPTED.

#### LATE INFORMATIONAL ITEM:

<u>FIS 17-106 Department of Health and Human Services</u> – Jeffrey Meyers, Commissioner, and Sheri Rockburn, Chief Financial Officer, Department of Health and Human Services presented the report and responded to questions of the Committee regarding the Modified Operating Statistics Dashboard report as of May 31, 2017 for the fiscal year ending June 30, 2017.
