- A. **MOTION TO RECONSIDER** Department of Resources and Economic Development item LRCP 10-034 and Department of Transportation item LRCP 10-035 requests approved by the Long Range Capital Planning and Utilization Committee April 13, 2010
- B. **MOTION TO DENY** the combined, amended and approved requests from the Department of Resources and Economic Development, Office of the Commissioner (LRCP 10-034), and the Department of Transportation, Bureau of Right-of-Way (LRCP 10-035), to respectively sell 6.2 acres of State owned land known as the "Connecticut Lakes State Forest" and 1.9 acres of State owned roadway right-of-way (approximately 775 feet), for a total combined acreage of 8.1 acres located within the Connecticut Lake State Forest on the northern most section of US Route 3 in the Town of Pittsburg to the U.S. Government for the total amended price of \$125,000, which includes all State fees and services, not \$3,300 per acre plus Administrative Fees, as approved by the Long Range Capital Planning and Utilization Committee April 13, 2010.

**RSA 4:39-c Disposal of Highway or Turnpike Funded Real Estate:**

LRCP 10-038 Department of Transportation – request authorization to sell 1.9 acres +/- of State owned roadway right-of-way (approximately 775 feet) located within the Connecticut Lake State Forest on the northern most section of US Route 3 in the Town of Pittsburg to the U.S. Government for \$16,420, which includes the Administrative Fees, as specified in the request dated April 26, 2010. This item (LRCP 10-035) was originally approved by the Long Range Capital Planning and Utilization Committee jointly with the Department of Resources and Economic Development (Item LRCP 10-034) on April 13, 2010.

**RSA 4:40 Disposal of Real Estate:**

LRCP 10-039 Department of Resources and Economic Development – request authorization to sell, by Quitclaim Deed, 6.2 acres of state owned land known as "Connecticut Lakes State Forest" to the U.S. Government in the Town of Pittsburg for \$53,580, including all Administrative Fees, as specified in the request dated April 27, 2010. This item (LRCP 10-034) was originally approved by the Long Range Capital Planning and Utilization Committee jointly with the Department of Transportation (Item LRCP 10-035) on April 13, 2010.
