<u>LRCP 20-007 Department of Transportation</u> – Stephen LaBonte, Administrator, Bureau of Right-of-Way, Department of Transportation, notified the Committee that there was a typographical error in the item submitted and that the requested amount of the sale should be \$59,600, not \$59,595.
