The Chair announced that all items under this section would be by block vote.

LRCP 21-009 Department of Transportation – On a motion by Senator Giuda, that the Committee waive the \$1,100 Administrative Fee as requested by the Town of Rumney. Stephen LaBonte, Administrator, Bureau of Right-of-Way, Department of Transportation, notified the Committee that the Town of Rumney offered to pay the \$141,000, which includes the Administrative Fee. As there was no second to Senator Giuda's motion, no further action was taken.
