Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Committee Established. There is established a committee to study and develop a plan for 1 $\mathbf{2}$ establishing an office of the inspector general.

3 2 Membership and Compensation.

I. The members of the committee shall be as follows:

(a) Four members of the senate, 2 of whom shall be members of the judiciary committee $\mathbf{5}$ and 2 of whom shall be members of the executive departments and administration committee, 6 7appointed by the president of the senate.

8 (b) Four members of the house of representatives, 2 of whom shall be members of the judiciary committee and 2 of whom shall be members of the executive departments and 9 10administration committee, appointed by the speaker of the house of representatives.

11 II. Members of the committee shall receive mileage at the legislative rate when attending to 12the duties of the committee.

133 Duties. The committee shall study establishing an office of the inspector general. Upon majority agreement, the committee shall develop a plan which establishes an office of the inspector 1415general.

164 Chairperson; Quorum. The members of the study committee shall elect a chairperson from 17among the members. The first meeting of the committee shall be called by the first-named senate 18member. The first meeting of the committee shall be held within 45 days of the effective date of this 19section. Four members of the committee shall constitute a quorum.

20The committee shall report its findings and any recommendations for proposed 5 Report. legislation to the president of the senate, the speaker of the house of representatives, the senate 2122clerk, the house clerk, the governor, and the state library on or before November 1, 2012.
