STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Eleven

AN ACT establishing a committee to study establishing an office of the inspector general.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Committee Established. There is established a committee to study and develop a plan for
2 establishing an office of the inspector general.

3 2 Membership and Compensation.

4 I. The members of the committee shall be as follows:

5 (a) Four members of the senate, 2 of whom shall be members of the judiciary committee
6 and 2 of whom shall be members of the executive departments and administration committee,
7 appointed by the president of the senate.

8 (b) Four members of the house of representatives, 2 of whom shall be members of the
9 judiciary committee and 2 of whom shall be members of the executive departments and
10 administration committee, appointed by the speaker of the house of representatives.

11 II. Members of the committee shall receive mileage at the legislative rate when attending to
12 the duties of the committee.

13 3 Duties. The committee shall study establishing an office of the inspector general. Upon
14 majority agreement, the committee shall develop a plan which establishes an office of the inspector
15 general.

16 4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from
17 among the members. The first meeting of the committee shall be called by the first-named senate
18 member. The first meeting of the committee shall be held within 45 days of the effective date of this
19 section. Four members of the committee shall constitute a quorum.

20 5 Report. The committee shall report its findings and any recommendations for proposed
21 legislation to the president of the senate, the speaker of the house of representatives, the senate
22 clerk, the house clerk, the governor, and the state library on or before November 1, 2012.

23 6 Effective Date. This act shall take effect upon its passage.
