SENATE BILL ***234-FN***

AN ACT relative to salary grades for certain executive branch positions and relative to the retirement classification of certain state officials.

SPONSORS: Sen. D'Allesandro, Dist 20; Sen. Lambert, Dist 13

COMMITTEE: Executive Departments and Administration

AMENDED ANALYSIS

This bill:

I. Establishes the salary grades for certain positions in the liquor commission, the department of information technology, and the department of administrative services.

II. Repeals authorization for certain state employees to remain eligible for group II retirement status based on their prior service and group II membership.

AN ACT relative to salary grades for certain executive branch positions and relative to the retirement classification of certain state officials.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 226:1 Unclassified Salaries; Liquor Commission; Department of Information Technology.
2 Amend RSA 94:1-a, I(b) by inserting in grade GG the following:

- 3 I. Liquor commission, director of marketing, merchandising, and warehousing.
4 II. Liquor commission, director of enforcement and licensing.
5 III. Liquor commission, chief operating officer.
6 IV. Department of information technology, chief information security officer.

7 226:2 Unclassified Salaries; Public Utilities Commission; Department of Information
8 Technology. Amend RSA 94:1-a, I(b) by inserting in grade HH the following:

- 9 I. Public utilities commission, director of safety and security.
10 II. Department of information technology, director of agency software.

11 226:3 Unclassified Salaries; Department of Administrative Services. Amend RSA 94:1-a, I(b) by
12 inserting in grade JJ the following:

- 13 I. Department of administrative services, deputy commissioner.

14 226:4 Repeal. The following are repealed:

- 15 I. RSA 206:8-a, relative to group II eligibility of the executive director of fish and game.
16 II. RSA 21-P:5-a, III, relative to group II eligibility of the director of homeland security and
17 emergency management.
18 III. RSA 21-P:36-a, relative to group II eligibility of the assistant director of homeland
19 security and emergency management.
20 IV. RSA 21-H:8-a, relative to group II eligibility of the assistant commissioner and division
21 directors, department of corrections.

22 226:5 Applicability. The repeal of RSA 21-P:36-a in section 4 of this act shall not apply to the
23 individual serving as the assistant director of homeland security and emergency management on the
24 effective date of this act.

25 226:6 Effective Date. This act shall take effect upon its passage.
