In the Year of Our Lord Two Thousand Thirteen

AN ACT relative to the membership of the governor's commission on alcohol and drug abuse prevention, intervention, and treatment.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 84:1 Governor's Commission on Alcohol and Drug Abuse Prevention, Intervention, and
2 Treatment; Membership. Amend RSA 12-J:1, III(a) to read as follows:

3 (a)(1) The attorney general, ***or designee.***

4 (2) The adjutant general, ***or designee.***

5 (3) The administrative judge of the district courts, ***or designee.***

6 (4) The chairperson of the liquor commission, ***or designee.***

7 (5) The commissioner of the department of health and human services, ***or designee.***

8 (6) The director of juvenile justice services, department of health and human
9 services, ***or designee.***

10 (7) The commissioner of the department of education, ***or designee.***

11 (8) The commissioner of the department of corrections, ***or designee.***

12 (9) The commissioner of the department of safety, ***or designee.***

13 (10) The director of the office of alcohol and drug policy, department of health and
14 human services, ***or designee.***

15 ***(11) The commissioner of the department of insurance, or designee.***

16 84:2 New Paragraph; Governor's Commission on Alcohol and Drug Abuse Prevention,
17 Intervention, and Treatment; Membership. Amend RSA 12-J:1 by inserting after paragraph III the
18 following new paragraph:

19 IV.(a)(1) A representative of the Business and Industry Association of New Hampshire,
20 appointed by the association.

21 (2) A representative of the New Hampshire Medical Society, appointed by the
22 society.

23 (3) The chancellor of the community college system of New Hampshire, or designee.

24 (4) The chairman of the New Hampshire Suicide Prevention Council.

25 (5) A representative of the New Hampshire Nurses' Association, appointed by the
26 association.

27 (b) The members under this paragraph shall serve 3-year terms.
