HOUSE BILL **309**

AN ACT relative to filing for office.

COMMITTEE: Election Law

ANALYSIS

This bill clarifies requirements for filing on the last day of the filing period. This bill also requires a primary candidate to declare that he or she is a registered voter.

STATE OF NEW HAMPSHIRE

AN ACT relative to filing for office.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 14:1 Primary Candidate. Amend RSA 655:16 to read as follows:

2 655:16 Personal Filing. Except for those who must file with a town or city clerk, any person who
3 files on the last day of the filing period must do so in person before the secretary of state; provided,
4 however, that this requirement shall not apply to the filling of vacancies by party committees. ***If the***
5 ***person must file with a town or city clerk and is filing on the last day of the filing period,***
6 ***he or she shall do so in person.***

7 14:2 Declaration of Candidacy. Amend RSA 655:17 to read as follows:

8 655:17 Declaration of Candidacy. Declarations of candidacy shall be in the following form and
9 signed by the candidate:

10 I, _____, declare that I am domiciled in Ward _____, in the city (or town or
11 unincorporated place) of _____, county of _____, state of New Hampshire,
12 and am a ~~qualified~~ **registered** voter herein; that I am a registered member of the _____ party;
13 that I am a candidate for nomination for the office of _____ (or for delegate to the state
14 convention) to be made at the primary election to be held on the _____ day of _____; and I
15 hereby request that my name be printed on the official primary ballot of the party in which I am
16 registered as a candidate for such nomination or election. I declare that I am not a candidate for
17 incompatible offices as defined in RSA 655:10, and that I am not a federal employee which makes me
18 ineligible to file as a candidate for this office. I further declare that, if nominated as a candidate for
19 said office or if elected as such delegate, I will not withdraw; and that, if elected, I will be qualified
20 for and will assume the duties of said office.

21 14:3 Effective Date. This act shall take effect 60 days after its passage.
