Be it Enacted by the Senate and House of Representatives in General Court convened:

| 7 | (a) Three members of the house of representatives, appointed by the speaker of the |

| 9 | (b) Two members of the senate, appointed by the president of the senate. |
| 10 | II. Members of the committee shall receive mileage at the legislative rate when attending to |
| 11 | the duties of the committee. |
| 12 | 3 Duties. |
| 13 | I. The committee shall study the feasibility of cities and towns transferring insurance under |
| 14 | the Act. The committee's study shall include, but not be limited to: |
| 15 | (a) Whether there is an economic benefit to the municipalities to use the insurance |
| 16 | covered under the Act. |
| 17 | (b) Costs and mechanisms for the transfer of the insurance. |
| 18 | (c) Any other matter the committee deems appropriate to its study. |
| 19 | II. The committee may solicit information from any source the committee deems relevant to |
| 20 | its study of this issue. |
| 21 | 4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from |
| 22 | among the members. The first meeting of the committee shall be called by the first-named house |
| 23 | member. The first meeting of the committee shall be held within 45 days of the effective date of this |
| 24 | section. Four members of the committee shall constitute a quorum. |
| 25 | 5 Report. The committee shall report its findings and any recommendations for proposed |
| 26 | legislation to the speaker of the house of representatives, the president of the senate, the house |
| 27 | clerk, the senate clerk, the governor, and the state library on or before November 1, 2013. |
| 28 | 6 Effective Date. This act shall take effect upon its passage. |
