Be it Enacted by the Senate and House of Representatives in General Court convened:

1	154:1 Parental Rights ad Responsibilities; Support. Amend RSA 461-A:14, V to read as follows:
2	V. No child support order shall require a parent to contribute to an adult child's college
3	expenses or other educational expenses beyond the completion of high school, except as provided in
4	RSA 461-A:21.
5	154:2 New Sections; Agreement on College Expenses. Amend RSA 461-A by inserting after
6	section 20 the following new sections:
7	461-A:21 Agreement on College Expenses. Parents may agree to contribute to their child's
8	college expenses or other educational expenses beyond the completion of high school as part of a
9	stipulated decree, signed by both parents and approved by the court. The agreed-on contribution
10	may be made by one or both parents. The agreement may provide for contributions to an account to
11	save for college, for the use of an asset, or for payment of educational expenses as incurred. Any
12	such agreement shall specify the amount of the contribution, a percentage, or a formula to determine
13	the amount of the contribution.
14	461-A:22 Modification of Agreements on College Expenses. Every agreement made under
15	RSA 461-A:21 shall state whether the agreement either is modifiable or is not modifiable. To qualify
16	as not modifiable, the agreement shall state a specific dollar amount to be contributed by either or
17	both parents. If the parents' agreement states that it is modifiable, the legal test for modification

461-A:23 Enforcement of Agreements on College Expenses. The court shall enforce any parental agreement on educational expenses that meets the requirements of RSA 461-A:21.

- 461-A:24 Mediation of Agreements on College Expenses. Before any court hearing to modify or enforce any agreement to contribute to college expenses, the parties shall participate in mediation, either privately contracted mediation or mediation under RSA 461-A:7.
 - 154:3 Applicability. The requirements of RSA 461-A:21 as inserted by section 2 of this act shall not apply to parental agreements signed before the effective date of this act.
