This bill requires a disclosure statement by persons seeking a party's nomination for elective office to be filed with the declaration of candidacy.

AN ACT requiring a disclosure statement by persons seeking a party's nomination for elective office.

Be it Enacted by the Senate and House of Representatives in General Court convened:

The name of any person shall not be printed upon the ballot 3 of any party for a primary unless he or she is a registered member of that party, he or she shall have met the age and domicile qualifications for the office he or she seeks at the time of the general 4  $\mathbf{5}$ election, he or she meets all the other qualifications at the time of filing, and he or she shall file with 6 the appropriate official between the first Wednesday in June and the Friday of the following week a 7declaration of candidacy as provided in RSA 655:17 and a disclosure statement as provided in 8 RSA 655:17-d. 9 2 New Section; Disclosure Statement. Amend RSA 655 by inserting after section 17-c the 10following new section: 655:17-d Disclosure Statement. 11 12I.
