AN ACT establishing a commission to study palliative care and associated quality of life initiatives.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1	225:1 New Chapter; Commission to Study Palliative Care and Associated Quality of Life
2	Initiatives. Amend RSA by inserting after chapter 126-V the following new chapter:
3	CHAPTER 126-W
4	COMMISSION TO STUDY PALLIATIVE CARE AND
5	ASSOCIATED QUALITY OF LIFE INITIATIVES
6	126-W:1 Commission to Study Palliative Care and Associated Quality of Life Initiatives;
7	Membership; Duties.
8	I. There is established a commission to study palliative care and associated quality of life
9	initiatives. The members of the commission shall be appointed within 45 days of the effective date of
10	this chapter and shall be as follows:
11	(a) One member of the senate, appointed by the president of the senate.
12	(b) Three members of the house of representatives, appointed by the speaker of the
13	house of representatives.
14	(c) The commissioner of the department of health and human services, or designee.
15	(d) The commissioner of the insurance department, or designee.
16	(e) A licensed hospice and palliative care physician, appointed by the New Hampshire
17	Medical Society.
18	(f) A licensed hospice and palliative care nurse, appointed by the New Hampshire
19	Nurses' Association.
20	(g) A licensed social worker specializing in palliative care, appointed by the
21	New Hampshire chapter of the National Association of Social Workers.
22	(h) A representative of a hospital with a dedicated palliative care program, appointed by
23	the New Hampshire Hospital Association.
24	(i) A representative of a Medicare certified home health and hospice agency, appointed
25	by the Home Care Association of New Hampshire.
26	(j) A representative of the New Hampshire Hospice and Palliative Care Organization,
27	appointed by the organization.

1	(k) A representative of spiritual care professionals specializing in palliative care
2	appointed by the New Hampshire Council of Churches.
3	(l) A representative of a nursing home facility, appointed by the New Hampshire Health
4	Care Association.
5	(m) Two public members, appointed by the governor.
6	II. Legislative members of the commission shall receive mileage at the legislative rate when
7	attending to the duties of the commission.
8	III. The commission's duties shall include, but not be limited to:
9	(a) Assessing the general knowledge of the citizens of New Hampshire regarding
10	palliative care and hospice services.
11	(b) Evaluating the access, effectiveness, utilization, and timeliness of palliative and
12	hospice care.
13	(c) Considering requiring continuing education credits for professional relicensure of
14	health care providers involved with palliative, hospice, and pain management services.
15	(d) Reviewing options for increasing the knowledge and use by the public of advanced
16	directives, including directions to the providers regarding life sustaining treatment.
17	(e) Discussing potential deficits in third party payments for hospice or palliative care
18	services as a barrier for use of palliative and hospice care.
19	IV. The members of the commission shall elect a chairperson from among the members
20	The first meeting of the commission shall be called by the senate member. The first meeting of the
21	commission shall be held within 60 days of the effective date of this section. Eight members of the
22	commission shall constitute a quorum.
23	V. The commission shall report its findings and any recommendations for proposed
24	legislation to the president of the senate, the speaker of the house of representatives, the senate
25	clerk, the house clerk, the governor, and the state library in the form of an interim report on or
26	before November 1, 2013 and a final report on or before June 1, 2014.
27	225:2 Repeal. RSA 126-W:1, relative to the commission to study palliative care and associated
28	quality of life initiatives, is repealed.
29	225:3 Effective Date.
30	I. Section 2 of this act shall take effect June 1, 2014.
31	II. The remainder of this act shall take effect upon its passage.
