AN ACT establishing a committee to study police special details.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1	1 Committee Established; Police Special Details.
2	I. There is established a committee to study the use and efficacy of police special details.
3	II. The members of the committee shall be as follows:
4	(a) One member of the senate, appointed by the president of the senate.
5	(b) Three members of the house of representatives, appointed by the speaker of the
6	house of representatives.
7	III. Members of the committee shall receive mileage at the legislative rate when attending to
8	the duties of the committee.
9	IV. The committee shall study the use and efficacy of police special details, and alternatives
10	which may be available to towns, cities, and the state.
11	V. The members of the study committee shall elect a chairperson from among the members.
12	The first meeting of the committee shall be called by the senate member. The first meeting of the

SB 119 FISCAL NOTE

AN ACT directing the joint legislative historical committee to conduct a study of state house flag restoration and preservation.

FISCAL IMPACT:
