A RESOLUTION relative to special use permits in the White Mountain National Forest.

1	Whereas, the New Hampshire general court has adopted numerous resolutions relative to the
2	White Mountain National Forest over the last two decades, including HR 25 in the 1993 session,
3	HJR 7 in the 1999 session, HR 9 in the 1999 session, HCR 25 in the 2000 session, SJR 1 in the 2000
4	session, and SCR 2 in 2012; and
5	Whereas, each of these resolutions has affirmed and communicated the strong support of the
6	people of New Hampshire, through their elected representatives, for multiple use management in the
7	White Mountain National Forest, including sustainable forest and wildlife habitat management, and
8	traditional recreational uses such as hiking, fishing, hunting, downhill and cross-country skiing, and
9	snowmobiling; and
10	Whereas, the White Mountain National Forest, established by the Weeks Act almost a century
11	ago, through the efforts of New Hampshire citizens, represents the successful application of the
12	principles of natural resource protection combined with multiple use; and
13	Whereas, conservation and preservation of the 800,000-acre Forest's lands, watersheds, wildlife
14	habitats, natural scenic beauty, and resource use and recreation was the intent of the 1911 Weeks
15	Act; and
16	Whereas, this approach has become a tradition and the ethic for the forest throughout its 100
17	plus years of successful service to the citizens of the north country, the state, and the country; and
18	Whereas, any diversion from this tradition and ethic will have an adverse effect on the forest's
19	ability to continue to meet the needs of the communities of the north country and its 5,000,000 users
20	per year, the American public; now, therefore, be it
21	Resolved by the Senate, the House of Representatives concurring:
22	That the legislature reaffirms its commitment to the principles underlying the Weeks Act, and
23	supports continued management of the White Mountain National Forest for multiple uses as a part
24	of the National Forest System; and
25	That consideration by the USDA Forest Service of any special use permit in the White Mountain
26	National Forest should recognize the Forest's economic and social importance, its character and
27	presence within the New England region, and its unique environmental and natural characteristics;

29	That copies of this resolution be forwarded by the house clerk to the President of the
30	United States, the Speaker of the United States House of Representatives, the majority and minority

leadership of the Senate, to each member of the New Hampshire Congressional delegation, and to
