STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Fourteen*

AN ACT                    relative to membership of the police standards and training council.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1            38:1 Police Standards and Training Council; Public Members Added. Amend RSA 188-F:24, I to  
2 read as follows:

3            I. There is established a police standards and training council. It shall consist of [~~12~~] **14**  
4 members as follows:

5                    (a) [~~2~~] **Two** members shall be chiefs of police in towns;

6                    (b) [~~2~~] **Two** members shall be chiefs of police in cities;

7                    (c) [~~2~~] **Two** members shall be county sheriffs;

8                    (d) [~~2~~] **Two** members shall be judges of courts with criminal jurisdiction;

9                    (e) The chancellor of the community college system of New Hampshire, or designee;

10                    (f) The director of the division of state police, or designee;

11                    (g) The attorney general, or designee[~~-and~~];

12                    (h) The commissioner of the department of corrections, or designee[-]; **and**

13                    (i) **Two public members, neither of whom shall be a certified police officer,**  
14 **lawyer, or judge, and neither of whom shall have a spouse, sibling, or parent, by birth,**  
15 **adoption, or marriage, who is a certified police officer, lawyer, or judge.**

16            38:2 Police Standards and Training Council. Amend RSA 188-F:24, IV to read as follows:

17            IV. Notwithstanding the provisions of any statute, ordinance, local law, or charter provision  
18 to the contrary **and except as otherwise provided in subparagraph I(i) regarding**  
19 **qualification of public members**, membership on the council shall not disqualify any member  
20 from holding any other public office or employment, or cause the forfeiture of any office or  
21 employment.

22            38:3 Effective Date. This act shall take effect 60 days after its passage.
