# AN ACT establishing a committee to study offshore wind energy and the development of other ocean power technology.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1	180:1 Committee Established. There is established a committee to study offshore wind energy
2	and the development of other ocean power technology.
3	180:2 Membership and Compensation.
4	I. The members of the committee shall be as follows:
<b>5</b>	(a) Three members of the house of representatives, appointed by the speaker of the
6	house of representatives.
7	(b) Three members of the senate, appointed by the president of the senate.
8	II. Members of the committee shall receive mileage at the legislative rate when attending to
9	the duties of the committee.
10	180:3 Duties.
11	I. The committee shall study offshore wind energy and the development of other ocean power
12	technology, including but not limited to:
13	(a) Determining potential power generation capacity in New Hampshire offshore waters.
14	(b) Identifying opportunities and possible facilities in the Portsmouth Harbor and other
15	coastal communities for support of offshore ocean power development.
16	(c) Identifying existing regulatory and jurisdictional challenges to enabling future
17	offshore power development.
18	(d) Projecting likely benefits to the state economy from this type of development over the
19	next decade.
20	II. The committee may solicit testimony from any person or organization with information
21	relevant to the committee's objective.
22	180:4 Chairperson; Quorum. The members of the study committee shall elect a chairperson
23	from among the members. The first meeting of the committee shall be called by the first-named
24	house member. The first meeting of the committee shall be held within 45 days of the effective date
25	of this section. Four members of the committee shall constitute a quorum.
26	180:5 Report. The committee shall report its findings and any recommendations for proposed
27	legislation to the speaker of the house of representatives, the president of the senate, the house
28	clerk, the senate clerk, the governor, and the state library on or before November 1, 2014.
29	180:6 Effective Date. This act shall take effect upon its passage.
