#### ANALYSIS

This bill prohibits the New Hampshire veterans' home from discriminating in its admissions policy against veterans who smoke. The bill also requires the New Hampshire veterans' home to study smoking policies at veterans' homes in other states and propose a policy to accommodate New Hampshire veterans who smoke.
