STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Fourteen*

A RESOLUTION urging Congress to fund the development and implementation of a comprehensive health care delivery system to enhance the level of specialty care for New Hampshire's veterans.

1       Whereas, New Hampshire is a proud and patriotic state with approximately 131,000 veterans  
2 with the majority over the age of 65 who have served their country bravely and risked their lives to  
3 preserve our country's freedom and democracy, and their sacrifices on our behalf are deserving of an  
4 upgraded medical delivery system to meet their health care needs; and

5       Whereas, New Hampshire is largely a rural state with limited access to the interstate highway  
6 system requiring veterans residing in many rural communities who may be ill and elderly to travel  
7 many miles to appointments for even minor procedures often placing undue and unnecessary stress  
8 on sick or injured veterans and their families; and

9       Whereas, many New Hampshire veterans residing in rural communities frequently miss  
10 essential checkups and therapies due to inclement weather and lack of proper transportation; and

11       Whereas, timely medical treatment would improve the overall health and quality of life of  
12 veterans by preventing numerous strokes, by-passes, amputations, and other costly but preventable  
13 conditions; and

14       Whereas, many New Hampshire veterans over the age of 65 do not have access to a primary care  
15 provider; and

16       Whereas, veterans residing in rural communities deserve the same level of care as veterans  
17 residing in other areas of the state; and

18       Whereas, New Hampshire is one of only 2 states in the nation without a full-service veterans'  
19 hospital, requiring veterans to travel to Vermont, Massachusetts, Maine, and Rhode Island for  
20 medical treatment; and

21       Whereas, adequate care of our veterans should be the concern of all Americans; now, therefore,  
22 be it

23       Resolved by the House of Representatives:

24       That the New Hampshire house of representatives respectfully urges the Congress of the  
25 United States and the Department of Veterans Affairs to fulfill the Department's goal of providing  
26 excellence in patient care by increasing the types of and access to specialty care at a full service  
27 VA Manchester Medical Center, or by developing a pilot program to utilize a veteran's medical card  
28 for use in New Hampshire's medical facilities in order to provide better care to veterans residing in  
29 rural areas, or by the establishment of additional community-based outpatient clinics, mobile clinics,  
30 or veterans' centers as justified by veterans' medical and mental health needs, or where cost  
31 effective, by entering into private service contracts with the goal of increasing services and reducing

1 travel time to ensure that access to health care is available when it is needed; and

2 That the house clerk forward official copies of this resolution to the President of the  
3 United States, the Speaker of the United States House of Representatives, the President of the  
4 United States Senate, the Secretary of Veterans Affairs, and to all the members of the  
5 New Hampshire congressional delegation with the request that this resolution be officially entered in  
6 the Congressional Record as a high priority for the Congress of the United States of America.
