AN ACT establishing the division of economic development fund.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 316:1 New Subdivision; Division of Economic Development Fund. Amend RSA 12-A by inserting 2 after section 61 the following new subdivision:

Division of Economic Development Fund

12-A:62 Division of Economic Development Fund. There is hereby established in the office of the 4 state treasurer a fund to be known as the division of economic development fund. The commissioner $\mathbf{5}$ of resources and economic development is authorized to accept public sector and private sector 6 7grants, gifts, or donations of any kind for the purpose of funding initiatives associated with the 8 purpose of this subdivision. The purpose of this subdivision shall be defined as the activities set 9 forth in RSA 12-A:22. Such grants, gifts, and donations shall be deposited in the division of economic 10 development fund and may only be expended by the commissioner of resources and economic 11 development to accomplish the purposes of this subdivision. Other than acknowledgement for 12promotional purposes, donations shall not be used as fees for services in a manner that primarily 13benefits the party providing the funds. The state treasurer may invest moneys in the fund as 14provided by law, with interest received on such investment credited to the fund. The moneys in this 15fund shall be nonlapsing and shall be continually appropriated to the department of resources and 16economic development.
