STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Fourteen

AN ACT relative to the board of dental examiners.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 11:1 Board of Dental Examiners; Executive Director. Amend RSA 317-A:4, I(g) to read as
2 follows:

3 (g) May request the state of New Hampshire director of dental health to serve as
4 executive [~~secretary to~~] **director of** the board.

5 11:2 Board of Dental Examiners; Executive Director. Amend RSA 317-A:4, II to read as follows:

6 II. The board shall choose one of its members as its president and one of its members as vice-
7 president. Five members shall constitute a quorum. No board action shall be taken without an
8 affirmative vote of the majority of board members present and eligible to participate in the matter in
9 question. Board members shall not be eligible to participate in a vote when the board member has
10 recused himself or herself from participation due to a conflict of interest. The board shall meet once
11 a year and at such other times and places as it may deem proper. A true record of all their official
12 acts shall be made and preserved by the board's executive [~~secretary~~] **director**. The records shall be
13 public and shall be open to inspection at all reasonable times, except for records compiled in
14 connection with disciplinary proceedings, which are subject to RSA 317-A:18.

15 11:3 Board of Dental Examiners; Executive Director. Amend RSA 317-A:5 to read as follows:

16 317-A:5 Report; Receipts. The board shall make a biennial report of its proceedings to the
17 governor and council in October, and all fees and fines received by the board shall be paid monthly
18 by the executive [~~secretary~~] **director** to the state treasurer.

19 11:4 Board of Dental Examiners; Executive Director. Amend RSA 317-A:35 to read as follows:

20 317-A:35 Disposal of Fines. All fines imposed and collected under this chapter shall be paid by
21 the court or justice to the executive [~~secretary~~] **director** of the board.

22 11:5 Effective Date. This act shall take effect upon its passage.
