AN ACT authorizing tenant brewing.

Be it Enacted by the Senate and House of Representatives in General Court convened:

200:1 New Paragraph; Definitions; Host Brewer. Amend RSA 175:1 by inserting after
 paragraph XXXVI-a the following new paragraph:

3 XXXVI-b. "Host brewer" means a beverage manufacturer who has entered into host-tenant 4 partnership with a tenant brewer licensed under RSA 178:12-b for the purpose of producing or 5 packaging beer or specialty beer on behalf of the tenant brewer.

29	and which employees are working on production of the tenant brewer's product.
30	VI. A tenant brewer is subject to the same reporting requirements as a beverage
31	manufacturer licensed under RSA 178:12.
32	VII. The annual fee for each license issued under this section shall be \$240.
