STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Fourteen

AN ACT establishing a committee to study the creation of a flood mitigation fund for private and municipal property owners.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 205:1 Committee Established. There is established a committee to study the creation of a flood
2 mitigation fund for private and municipal property owners.

3 205:2 Membership and Compensation.

4 I. The members of the committee shall be as follows:

5 (a) One member of the senate, appointed by the president of the senate.

6 (b) Two members of the house of representatives, appointed by the speaker of the house
7 of representatives.

8 II. Members of the committee shall receive mileage at the legislative rate when attending to
9 the duties of the committee.

10 205:3 Duties. The committee shall study the creation of a flood mitigation fund for private and
11 municipal property owners.

12 205:4 Chairperson; Quorum. The members of the study committee shall elect a chairperson
13 from among the members. The first meeting of the committee shall be called by the senate member.
14 The first meeting of the committee shall be held within 45 days of the effective date of this section.
15 Two members of the committee shall constitute a quorum.

16 205:5 Report. The committee shall report its findings and any recommendations for proposed
17 legislation to the president of the senate, the speaker of the house of representatives, the senate
18 clerk, the house clerk, the governor, and the state library on or before November 1, 2014.

19 205:6 Effective Date. This act shall take effect upon its passage.
