Be it Enacted by the Senate and House of Representatives in General Court convened:

| 1 | 99:1 Rights Lost. Amend RSA 607-A:2, I to read as follows: |

| 20 | file as a candidate for this office. If I have been convicted of a felony, I declare that I have |
| 21 | completed my sentence as required in RSA 607-A:2. I further declare that, if nominated as a |
| 22 | candidate for said office or if elected as such delegate, I will not withdraw; and that, if elected, I will |
| 23 | be qualified for and will assume the duties of said office. |

| 21 | III. (For use by candidate for state senate): I,, candidate for the office of |

| 23 | of New Hampshire for at least 7 years immediately preceding the election for which I am a |
| 24 | candidate, that my domicile is in senatorial district no at the present time, that I |
| 25 | will be at least 30 years of age on the day of said election, [and] that I am not a candidate for |
| 26 | incompatible offices as defined in RSA 655:10, [and] that I am not a federal employee, and that I |
| 27 | am not a convicted felon who has not yet received a final discharge from sentencing. |
| 28 | IV. (For use by candidate for state representative): I,, candidate for the |
| 29 | office of representative from district no of county, hereby swear (or affirm) |
| 30 | that I have been domiciled in the state of New Hampshire for at least 2 years immediately preceding |
| 31 | the election for which I am a candidate, that I am now domiciled in district no of |
| 32 | county, the district I seek to represent, that I will be at least 18 years of age on the day |
| 33 | of said election, that I am not a candidate for incompatible offices as defined in RSA 655:10, [and] |
| 34 | that I am not a federal employee, and that I am not a convicted felon who has not yet received |
| 35 | a final discharge from sentencing. I further recognize that, if elected, I will serve as a delegate |
| 36 | to the county convention. |
