STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Fifteen*

AN ACT                    establishing a committee to study a number plate commemorating Laconia  
Motorcycle Week.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1            108:1 Committee Established. There is established a committee to study creating a number  
2 plate commemorating Laconia Motorcycle Week.

3            108:2 Membership and Compensation.

4            I. The members of the committee shall be as follows:

5                    (a) One member of the senate, appointed by the president of the senate.

6                    (b) Three members of the house of representatives, appointed by the speaker of the  
7 house of representatives.

8            II. Members of the committee shall receive mileage at the legislative rate when attending to  
9 the duties of the committee.

10           108:3 Duties. The committee shall evaluate the merits of creating a 100<sup>th</sup> anniversary  
11 commemorative number plate to fund promoting travel and tourism associated with Laconia  
12 Motorcycle Week.

13           108:4 Chairperson; Quorum. The members of the study committee shall elect a chairperson  
14 from among the members. The first meeting of the committee shall be called by the first-named  
15 senate member. The first meeting of the committee shall be held within 45 days of the effective date  
16 of this section.

17           108:5 Report. The committee shall report its findings and any recommendations for proposed  
18 legislation to the president of the senate, the speaker of the house of representatives, the senate  
19 clerk, the house clerk, the governor, and the state library on or before November 1, 2015.

20           108:6 Effective Date. This act shall take effect upon its passage.
