#### 5. Short Title: **Collateralization of Public Deposits**

Summary of what the rule says and of any proposed amendments: 6. (a)

> Ban 1450 establishes the types of holdings that a depository bank in New Hampshire may pledge to collateralize public deposits.

This proposal is necessary to continue to conform Ban 1450 to the newly codified state statute, RSA 383-B, that was adopted during the 2015 legislative session, and which became effective October 1, 2015. Chapter Law 272 had repealed RSA 386 and RSA 387 under which Ban 1450 was previously authorized. However, nearly identical language was adopted in Chapter Law 272:16 which permits the Banking Department to continue this rule in substantially the same form. Effective December 23, 2015, the Banking Commissioner adopted interim rule Ban 1450 to address the above issues. Now the Banking Commissioner will readopt Ban 1450 with amendment through the regular rulemaking process.

The amendment in this proposal carries over and defines the term "NRSRO" consistent with RSA 383-B and resolves a typographical error in Ban 1450.04(a).
