Senator Giuda questioned if it was possible for the Department to aggregate the cost of Doorways and any associated programs into a single dollar figure to get an estimate of how much the system is costing, to which the Department responded that they have the figures going back to 2018. He also asked if the Department could pull together the numbers under the broad categories for prevention, treatment, and interdiction, to have a representation of the balance of funding towards these different efforts.

The Chair also felt it would be helpful to get the caseload figures from the Courts to help determine if prevention is working.
