

Amendment to HB 2-FN-A-LOCAL

1 1 County Nursing Homes; Proportionate Share Payments. Amend RSA 167:18-h to read as
2 follows:

3 167:18-h County Nursing Homes; Proportionate Share Payments.

4 I. Proportionate share payments to county nursing homes shall be made each state fiscal
5 year in an amount equal to the maximum permissible by federal regulations. All payments shall be
6 [apportioned] **specific** to each facility in [~~a percentage equal to that facility's proportion of total~~
7 ~~county nursing home medicaid utilization~~] **accordance with the methodology in the approved**
8 **Medicaid state plan amendment**. If the federal government makes adjustments to any
9 proportionate share payments that have been made by the state, the amounts due under this
10 section shall be amended accordingly and adjusted payments shall be made to or from the state as
11 necessary.

12 II. [~~Notwithstanding any provision of law to the contrary, each county government shall~~
13 ~~reimburse the state for 50 percent of the total cost of proportionate share payments made to the~~
14 ~~county pursuant to paragraph I~~].

15 (a) **The certified public expenditure (CPE) nursing facilities group shall be**
16 **financed on the basis of a CPE methodology and shall not require a transfer of funds from**
17 **the respective county to the state to effectuate the federal match.**

18 (b) **Any intergovernmental transfers (IGT) specific to the IGT nursing facilities**
19 **group that serve as the basis for generating the federal match shall originate from the**
20 **county.**

1. Clarifies proportionate share payments to county nursing homes.

Amendment to HB 2-FN-A-LOCAL

1 1 New Subdivision; Lead Paint Hazard Remediation Fund. Amend RSA 204-C by inserting
2 after section 87 the following new subdivision:

3 Lead Paint Hazard Remediation Fund

4 204-C:88 Definitions. In this subdivision:

5 I. "Multi-unit" means more than one dwelling unit.

6 II. "Property" means a rental or owner-occupied residential property, or a child care facility
7 licensed under RSA 170-E.

8 III. "Unit" means a single dwelling unit within a structure that contains more than one
9 dwelling unit. "Unit" may also include any dwelling unit within a structure that is otherwise used
10 for non-residential purposes.

11 204-C:89 Lead Paint Hazard Remediation Fund Established.

12 I. There is hereby established within the authority a fund to be used for the purposes of
13 remediating lead paint hazards in housing, to be known as the lead paint hazard remediation fund.
14 The lead paint hazard remediation fund shall be composed of appropriations, gifts, grants,
15 donations, bequests, or other moneys from any public or private source, but such revenues shall not
16 be deemed to be money received from the state, and nothing in this subdivision shall be construed
17 as pledging the faith and credit of the state.

18 II. The authority may use the lead paint hazard remediation fund to make loans to owners
19 of properties for the costs of remediation of lead paint hazards. The authority may also make loans
20 to owners of licensed child care facilities for remediation of lead in water. Loans may be made
21 provided that such remediation is conducted in accordance with lead-safe practices under applicable
22 laws and regulations.

23 III. The authority may use up to 5 percent of any funds deposited in the lead paint hazard
24 remediation fund for program administration.

25 204-C:90 Eligibility. For a property to be eligible to use the funding under this subdivision, the
26 property shall be:

27 I. An owner-occupied single family home occupied by a household with a child under 6
28 years or a pregnant woman and where household income is no more than 100 percent of the median
29 income adjusted for household size for the metropolitan area or county in which the housing is
30 located as published annually by the United States Department of Housing and Urban
31 Development;

32 II. A unit in a multi-unit residential property or a renter-occupied single family home

1 where household income is no more than 90 percent of the median income adjusted for household
2 size for the metropolitan area or county in which the housing is located as published annually by
3 the United States Department of Housing and Urban Development; or

4 III. A child care facility licensed under RSA 170-E.

5 204-C:91 Use of Federal Funds. The lead paint hazard remediation fund shall only be used to
6 supplement, but not supplant, existing federal resources. If a property or unit is eligible for federal
7 funding from a program in operation by the authority, or by any state agency or political
8 subdivision, the owner of the property shall first apply to that program before applying to the lead
9 paint hazard remediation fund.

10 204-C:92 Rulemaking. Pursuant to RSA 204-C:53, the authority shall adopt rules governing
11 the distribution the lead paint hazard remediation fund.

12 2 New Subparagraph; Application of Receipts. Amend RSA 6:12, I(b) by inserting after
13 subparagraph (343) the following new subparagraph:

14 (344) Moneys deposited in the lead paint hazard remediation fund established
15 under RSA 204-C:89.

16 3 Repeal. Loans for Lead Hazard Remediation Projects. RSA 130-A:15-a, relative to loans for
17 lead hazard remediation projects, is repealed.

18 4 Appropriation; Lead Paint Hazard Remediation Fund. The sum of \$3,000,000 for the fiscal
19 year ending June 30, 2020 is hereby appropriated to the lead paint hazard remediation fund
20 established in RSA 204-C:89. The governor is authorized to draw a warrant for said sum out of any
21 money in the treasury not otherwise appropriated.
