NEW BUSINESS:

CHAPTER 351:5, LAWS OF 1991, AS AMENDED BY CHAPTER 2, LAWS OF 2013, APPROPRIATION, PORT AUTHORITY:

<u>CAP 18-018 Pease Development Authority, Division of Ports and Harbors</u> – Geno Marconi, Director, Division of Port and Harbors, Pease Development Authority, presented the request and responded to questions of the Committee.

On a motion by Representative Byron, seconded by Representative Graham, that the Committee approve the request of the Pease Development Authority, Division of Ports and Harbors, to expend not more than \$12,985 from the Port Expansion Fund for a Proposal for Engineering and Planning Services from Appledore Marine Engineering to Assist the Port Director in Preparing a BUILD Grant Application for Rehabilitation of the NH Port Authority Main Wharf, Portsmouth, N.H., as specified in the request dated July 5, 2018. MOTION ADOPTED.

RSA 12-G:46, III, HARBOR DREDGING AND PIER MAINTENANCE FUND ESTABLISHED:

<u>CAP 18-019 Pease Development Authority, Division of Ports and Harbors</u> – Geno Marconi, Director, Division of Port and Harbors, Pease Development Authority, presented the request and responded to questions of the Committee.

On a motion by Senator D'Allesandro, seconded by Senator Birdsell, that the Committee approve the request of the Pease Development Authority, Division of Ports and Harbors, to expend \$29,950 from the Harbor Dredging and Pier Maintenance fund for a proposed concept study of the Portsmouth Commercial Fish Pier to be performed by Appledore Marine Engineering, LLC., as specified in the request dated August 16, 2018.
