## RSA 228:12-a USE OF TOLL CREDITS:

<u>CAP 22-003 Department of Transportation</u> – Andre Briere, Deputy Commissioner, and Peter Stamnas, Director of Project Development, Department of Transportation, presented the request and responded to questions of the Committee.

On a motion by Senator Reagan, seconded by Senator Hennessey, that the Committee approve the request of the Department of Transportation for approval of; 1) the use of \$1,600,000 of Turnpike Toll Credit to meet funding match requirements for the proposed Hampton Branch Trail project based on the estimated cost for all work of \$13,000,000, and 2) requests approval for the use of Toll Credits for a 10% contingency amount of \$260,000 in excess of the approved \$2,600,000 to account for potential bid amounts in excess of the total project estimated costs of \$13,000,000 to meet funding match requirements for the proposed Hampton Branch Trail project, as specified in the request dated February 8, 2022. MOTION ADOPTED. (6-Yes; 0-No)

<u>CAP 22-004 Department of Administrative Services</u> – Karen Rantamaki, Director of Plant and Property, Department of Administrative Services, presented the request and responded to questions of the Committee.

On a motion by Senator Reagan, seconded by Representative Cloutier, that the Committee approve the request of the Department of Administrative Services to transfer \$165,044 of appropriations from the completed capital project Paint & Carpentry – Upgrade Electrical Service and Entrance, Chapter 146:11, C, 5, to capital project Concord Steam – Raze Structurally Deficient Building, Chapter 146:II, C, 1, as specified in the request dated March 14, 2022. MOTION ADOPTED. (6-Yes; 0-No)
