INFORMATIONAL MATERIALS:

At the request of Senator D'Allesandro, Kerrin Rounds, Chief Financial Officer, Katja Fox, Director, Division of Behavioral Health, Heather Moquin, Chief Executive Officer, New Hampshire Hospital, and Henry Lipman, Director, Office of Medicaid and Business Policy, Department of Health and Human Services, responded to questions of the Committee regarding FIS 21-085 Department of Health and Human Services – Operating Statistics Dashboard SFY21 report through March 31, 2021.

The Department will provide the Committee with the following requested information; the Department and Finance vacancy rate figures, and the FY21 lapse estimates, which they will also share with Senate Finance.

Katja Fox responded to the question of "when will the balance of the fully funded 40 Transitional Housing beds be available," answering that the balance of the 40 beds would not be coming online by the end of the biennium due to the lack of viable applications due to the Medicaid rates. Senator Rosenwald asked if the \$5 million in the budget would lapse, and Kerrin Rounds will look at the appropriation to verify whether the money will lapse or not.

Heather Moquin responded to the question of "when will the additional beds at Hampstead Hospital be coming online and how many," reporting that there will be an additional seven (7) beds available by the first week in May.

Henry Lipman responded to the questions of "where do we stand on the growth of the number of children receiving Medicaid since last July until now" and "how many children receive Medicaid," answering the questions and reporting that 94,442 is the current enrollment of children being served as of the end of March.

When questioned if Medicaid is sufficiently funded, the Department responded they were adequately funded for Fiscal Year 21 and will go before the Senate once they know how they will end this fiscal year to decide where they will be for the next biennium.

Senator Rosenwald asked what percentage of the increase in caseloads is due to new enrollees or pushing back the redeterminations, to which he responded that 22,000 individuals fall under redeterminations and 40,000 are new enrollees.

AUDIT INFORMATIONAL MATERIEALS:

FIS 21-087 Department of Education and FIS 21-088 NH Liquor Commission were submitted as late informational items.

The Committee noted they found it helpful that the NH Liquor Commission included percentages for the completed status fields and hoped all agencies would include them on their status updates. LBA will notify agencies. The Committee also requested that dates of completion be noted for each finding or identify what has been completed since the last update.

Senator Giuda questioned receiving updates from the Department of Environmental Services regarding the Wetlands Bureau Permitting performance audit presented May of 2019. Michael Kane, Legislative Budget Assistant, told the Committee that by Executive Order 2014-3 agencies are required to provide a status report 30 days after the issuance of an audit, as well as every six (6) months thereafter until all findings have been resolved.
