FIS 07-257 Department of Health and Human Services – On a motion by Senator Larsen, seconded by Representative Wallner, that the Committee approve the request from the Department of Health and Human Services to retroactively establish an atypical rate for services to children under three years of age at Cedarcrest, Inc. from July 1, 2007 through June 30, 2009. MOTION ADOPTED. (9-Yes, 1-No)

FIS 07-250 New Hampshire Lottery Commission – On a motion by Senator Burling, seconded by Representative Franklin, that the Committee approve the request from the New Hampshire Lottery Commission to transfer \$2,300,000 from the Lottery Special Revenue Account to the Instant Ticket Account for the period of July 1, 2007 through June 30, 2008. MOTION ADOPTED.

FIS 07-281 Department of Health and Human Services – Nicholas Toumpas, Acting Commissioner, Nancy Rollins, Director, Division of Community Based Services and James Fredyma, Controller, Department of Health and Human Services responded to questions of the Committee.

On a motion by Senator Larsen, seconded by Representative Wallner, that the Committee approve the request from the Department of Health and Human Services to accept and expend \$200,000 from the State Treasurer, from funds not otherwise appropriated, through June 30, 2008. The motion was withdrawn by Senator Larsen and Representative Wallner respectively.

On a motion by Representative Wallner, seconded by Senator Burling, that the Committee table the request from the Department of Health and Human Services and instruct the Department to advance the necessary funds on a quarterly basis to the Community Action Program for the purpose of the Homeless Housing Guarantee. NO ACTION TAKEN.

On an **amended motion** by Representative Wallner, seconded by Senator Burling, that the Committee table the request from the Department of Health and Human Services, **with no qualifications**. The Committee will recess at the end of this meeting until September 5, 2007, at 1:00 p.m., at which time the Department of Health and Human Services will be prepared to come back before the Fiscal Committee. MOTION ADOPTED.
