- 1. The meeting was convened at 9:02 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan, were Sens. Avard, French, and Ward, and Reps. Schmidt, Hatch, Wolf, and Matthews.

Sen. Feltes arrived in the meeting at this time. Rep. Ebel was no longer a voting member.

6. The Committee discussed Proposed Interim Rule INT 2018-23 from the Department of Health and Human Services (Former Division of Mental Health and Developmental Services, Certification Standards for Community Residences).

Rep. Schmidt moved that the Committee approve Proposed Interim Rule INT 2018-23.
