In response to the objection, the Board had withdrawn the rules in a letter dated October 2, 2018. No further Committee action was required.

The Committee took no further action.

9. The Committee discussed requesting a waiver from the Director of the Office of Legislative Services of its December 10, 2018 action deadline on Final Proposal 2018-159 from the Board of Nursing (Application Procedure), since the Committee had postponed this item and the Board had requested a postponement to the January, 2019 Committee meeting.

Sen. Kahn moved that the Committee request a waiver.

10. The Committee discussed Final Proposal 2018-121 from the Department of Health and Human Services (Former Division of Mental Health and Developmental Services, Eligibility and the Process of Providing Services for Acquired Brain Disorder). Allyson Zinno and Melissa Nemeth testified for the Department.

The Department had submitted a conditional approval request in a letter dated November 14, 2018 and amended rules dated November 13, 2018.

Rep. McGuire moved that the Committee conditionally approve Final Proposal 2018-121 based on the request and the further condition that the Department submit screen shots of the data entry screens for the website cited in He-M 522.14(f).

12. The Committee discussed Final Proposal 2018-155 from the Department of Health and Human Services (Commissioner, Certification Payment Standards for Communication Access Services). Allyson Zinno and James Panzer testified for the Department.

Sen. Kahn moved that the Committee conditionally approve Final Proposal 2018-155 on the condition that the Final Proposal be amended as follows.

- Deletion of the phrase "along with sensitivity to the culture of individuals needing communication assistance," in He-C 6341.06(a)(1) and He-C 6341.07(a)(1);
- Insertion of ", someone who is able to read effectively, accurately, and impartially, using any necessary specialized vocabulary" after "reader" in He-C 6341.06(a)(3)a.;
- Replacement of the phrase "issues by the licensing authorities as applicable" with "contained in Int 500" in He-C 6341.06(a)(7) and He-C 6341.07(a)(7); and
- Insertion at the end of He-C 6341.12(e)(1) of the words "that includes the following certification statement:", and below this language the inclusion, in quotations, of the list of 8 statements from the attached page 2 of Form 2679.

Sen. Reagan designated Rep. Ebel as an alternate for Rep. Schmidt, who was absent.

13. The Committee discussed Proposed Interim Rule INT 2018-24 from the Department of Health and Human Services (Former Division of Human Services, Non-Emergency Walk-In Care Centers). Allyson Zinno and Doreen Shockley testified for the Department.

Rep. Hatch moved that the Committee approve Proposed Interim Rule INT 2018-24.

14. The Committee discussed the response by the University System of New Hampshire to the Committee's preliminary objection to Final Proposal 2018-51 (Financial Policies on Classification of Students for Tuition Purposes). Ronald Rodgers, General Counsel, testified for the University System.

McGuire moved that the Committee take no action on the response to the objection with the understanding that (1) the University System may adopt the rules after December 26, 2018 but that it will continue to seek legislation as outlined in its response letter to clarify the scope of its rulemaking authority under RSA 541-A and RSA 187-A, and (2) Committee staff would revisit the rules in July 2019 to determine if any new legislation has fixed the issue.
