1. The meeting was convened at 9:02 a.m. by Sen. Reagan as Chair.

Sen. Feltes moved that the Committee approve Final Proposal 2017-132.

Sen. Avard seconded.

Adopted. Sen. Reagan noted there were two "no" votes.

8. The Committee discussed Final Proposal 2017-87 from the Department of Safety (Commissioner, New Hampshire Fire Standards and Training and EMS Administrative Fee Rules). David Hilts and Chief Jeffrey Phillips testified for the Department.

The Department had submitted a conditional approval request in amended rules dated October 18, 2017.

Rep. McGuire moved that the Committee make a preliminary objection to Final Proposal 2017-87 on the grounds as outlined in the annotations to Final Proposal 2017-87 by Committee staff but with the understanding that the Department, in preparing its objection response, would consider and avoid the issues outlined in the Committee staff's annotations to the Department's conditional approval request.

Adopted.

9. The Committee discussed Final Proposal 2017-74 from the Department of Safety (Commissioner, Licensure of Private Investigators, Security Guards, and Bail Recovery Agents). Keith Lohmann testified for the Department.

Sen. Feltes moved that the Committee make a preliminary objection to Final Proposal 2017-74 on the grounds as outlined in the annotations to the Final Proposal by Committee staff.

10. The Committee discussed Final Proposal 2017-129 from the Department of Safety (Commissioner, Transportation Network Company Rules). David Hilts testified for the Department.

Rep. McGuire moved that the Committee make a preliminary objection to Final Proposal 2017-129 on the grounds as outlined in the annotations to the Final Proposal by Committee staff.

11. The Committee discussed Final Proposal 2017-62 from the Board of Nursing (Licensees with the Authority to Delegate Nursing Related Activities; Eligibility to be a Delegatee). Robert Lamberti of the Office of Professional Licensure and Certification testified for the Board.

The Board had submitted a conditional approval request in a letter and amended rules dated November 15, 2017.

Michelle Winchester, who had submitted written testimony in an e-mail on October 18, 2017, also testified.

- In Nur 404.07(h)(4), insert "safely" before "self-administer" at the end of the sentence.

12. The Committee discussed Final Proposal 2017-94 from the Board of Dental Examiners (Licensing Requirements; Dental Assistants and Hygienist Duties; Ethical and Professional Standards). Robert Lamberti of the Office of Professional Licensure and Certification testified for the Board.

Sen. Feltes moved that the Committee approve Final Proposal 2017-94.

Adopted.

13. The Committee discussed Final Proposal 2017-99 from the Pharmacy Board (Collaborative Pharmacy Practice). Robert Lamberti of the Office of Professional Licensure and Certification testified for the Board.

The Board had submitted a conditional approval request in a letter and amended rules dated November 15, 2017.

Rep. Schmidt moved that the Committee conditionally approve Final Proposal 2017-99 based on the Board's conditional approval request.

Rep. Schmidt moved that the Committee approve Final Proposal 2017-120.
