# Action Minutes

## December 16, 2021

1. The meeting was convened as an in-person meeting at 9:00 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan, were Senators Gray and Ward, and Representatives Bershtein, Hatch, Lang, Schmidt, and Tucker.

Sen. Reagan designated Rep. Tucker as an alternate for Rep. McGuire, who was absent.

2. The Committee discussed whether to postpone action on certain items to another meeting.

11. The Committee discussed an emergency rule filed in Document #13304, effective December 10, 2021, by the Department of Health and Human Services (Temporary Acute Care Centers Located Within a Hospital).

12. The Committee discussed Final Proposal 2021-88 from the Fish and Game Department (Conservation of Threatened and Endangered Species). Christopher Aslin from the Department of Justice testified for the Fish and Game Department.
