December 17, 2020

- 1. The meeting was convened as a Zoom webinar at 9:00 a.m. by Rep. - Comment on page 13, by resolving the inconsistencies between Env-Dw 1106.03(g) and "Form 1: Final Application", NHDES-W-03-064; and
- Comment on page 24, by inserting the certification statement found on the form "Request for DWSRF Disbursement", NHDES-W-03-206, into the rule at Env-Dw 1107.07.
