Rep. McGuire moved that the Committee approve Final Proposal 2018-150.

Rep. Schmidt seconded.

Adopted.

8. The Committee discussed Final Proposal 2018-151 from the Office of Licensed Allied Health Professionals (Fees Charged by the Governing Boards). Thomas Broderick and Tina Kelley from the Office of Professional Licensure and Certification testified for the Office.

Rep. McGuire moved that the Committee conditionally approve Final Proposal 2018-151 on condition that the fee in Ahp 301.02 for transcribing eligibility records for physical therapy examination be reduced from \$45.00 to \$1.00.

Rep. Schmidt seconded.

Adopted.

9. The Committee discussed Final Proposal 2018-133 from the N.H. Retirement System (Rules of Practice and Procedure). Mark Cavanaugh testified for the System.

Rep. Schmidt moved that the Committee approve Final Proposal 2018-133.

Sen. Feltes seconded.

Adopted.

10. The Committee discussed Final Proposal 2018-123 from the N.H. Retirement System (Participation in the Retirement System). Mark Cavanaugh testified for the System.

Rep. Schmidt moved that the Committee approve Final Proposal 2018-123.

Adopted.

11. The Committee discussed Final Proposal 2018-124 from the N.H. Retirement System (Code of Ethics). Mark Cavanaugh testified for the System.

Rep. Schmidt moved that the Committee approve Final Proposal 2018-124 with the recommendation that the Retirement System seek legislative clarification of the System's status as an entity outside of the executive branch, particularly in regards to the applicability of RSA 21-G:21-35 on the executive branch code of ethics.

12. The Committee discussed Final Proposal 2018-174 from the N.H. Veterans' Home (Residency, Admission, Transfer, and Discharge Rules). Commandant Margaret D. LaBrecque and Paul Lloyd testified for the Home.

Sen. Reagan moved that the Committee approve Final Proposal 2018-174 with the understanding that the Home will address in another rulemaking proceeding the issues outlined in the annotations by Committee staff to the Final Proposal.

Rep. McGuire moved that the Committee make a preliminary objection to Final Proposal 2018-122 with the recommendation that the Department undertake regular rulemaking to address the issues outlined in the annotations by Committee staff to the Final Proposal.

14. The Committee discussed Final Proposal 2018-135 from the Department of Safety (Display Fireworks Rules). Assistant Director Maxim Schultz of the Division of Fire Safety and Christopher Wyman testified for the Department.

Sen. Feltes moved that the Committee postpone action on Final Proposal 2018-135 to the next Committee meeting.

15. The Committee discussed Final Proposal 2018-132 from the Department of Health and Human Services (Former Division of Public Health Services, Home Health Care Providers Licensing). Allyson Zinno and Doreen Shockley testified for the Department.

The Department had submitted a conditional approval request in a letter and amended rules dated December 17, 2018.

Rep. McGuire moved that the Committee conditionally approve Final Proposal 2018-132 as requested.

Rep. Schmidt seconded.

Adopted.

16. The Committee discussed Proposed Interim Rule INT 2018-25 from the Department of Health and Human Services (Former Division of Human Services, Granite Workforce Pilot Program). Kim Reeve, Lynn Wilder, and Richard Lavers testified for the Department.

Dawn McKinney, representing N.H. Legal Assistance, also testified.

The Department had submitted a conditional approval request in a letter and amended rules dated December 19, 2018.

Sen. Reagan moved that the Committee conditionally approve Proposed Interim Rule INT 2018-25 as requested but with the further amendment to change references in He-W 639.04(a)(4) from "18 years" to "19 years".

Sen. Feltes seconded.

Adopted.

17. The Committee discussed Proposed Interim Rule INT 2018-26 from the Department of Health and Human Services (Former Division of Human Services, N.H. Granite Advantage Health Care Program). Commissioner Jeffrey Meyers and Melissa St. Cyr testified for the Department.

Rep. McGuire left the meeting during the discussion of this item. Rep. Sytek was not designated at this time as an alternate for Rep. McGuire and so was not a voting member.

The following persons also testified:

Dawn McKinney, representing N.H. Legal Assistance, who also submitted written testimony.

Karen Rosenberg, representing the Disability Rights Center, who had previously submitted written testimony.

Jesse Burdwood and Chris Rueggeberg, representing the Council on Developmental Disabilities, which had previously submitted written testimony.

Sen. Feltes moved that the Committee object to Proposed Interim Rule INT 2018-26 on the grounds:

- (a) Stated in Committee staff comments including, but not limited to, the following:
 - 1. The Proposed Interim Rule is contrary to legislative intent by appearing to violate or conflict with federal statutory provisions or federal regulations, specifically the Americans with Disabilities Act;
 - 2. The Department lacks the authority to violate a provision of the U.S. Constitutions, specifically the Due Process Clause of Amendment V; and
 - 3. The Proposed Interim Rule is contrary to the public interest because the language is too broad and not clear so as to be understandable to the regulated community; and
- (b) That the Proposed Interim Rule is contrary to legislative intent by violating the overall purpose of RSA 126-AA including, but not limited to, issues relative to deficiency of hours, carry over of work hours, and exemptions relative to people with disabilities.

Sen. Reagan seconded.

Adopted.

18. The Committee discussed an emergency rule, Document #12688, effective December 7, 2018, from the Department of Health and Human Services (Former Division of Elderly and Adult Services, Nursing Facility Reimbursement – Budget Adjustment Factor). Kim Reeve, Robert Berry, and Jennifer Doig testified for the Department.

No further action was taken.

19. The Committee discussed an orientation session for new members.

It was the consensus of the Committee to postpone this item to the regular Committee meeting on January 18, 2019.

20. The Committee discussed the continued meeting scheduled for January 4, 2019.

It was the consensus of the Committee to cancel the continued meeting.
