## Action Minutes

## APRIL 15, 2016

Members Present: Senators Reagan, Cataldo, Feltes, and Daniels\*, and Representatives Schmidt, Kidder, and Hatch\*. (\*) Indicates alternate member.

1. The meeting was convened at 9:01 a.m. by Sen. Reagan, Vice-Chair, as Acting Chair.

Members present at this time, aside from Sen. Reagan were Sens. Cataldo and Daniels and Reps. Schmidt, Kidder, and Hatch.

Sen. Reagan designated Sen. Daniels and Rep. Hatch as alternates, respectively, for Sen. Watters and Rep. Sad, who were absent.

2. The Committee discussed the minutes of the Committee meetings on March 18, 2016, and April 1, 2016.

Sen. Feltes arrived during the discussion of this item.

Rep. Kidder moved that the minutes be approved.

Rep. Schmidt seconded.

Adopted.

Sen. Feltes returned to the meeting during the discussion of this item.

Rep. Schmidt moved that the Committee approve Final Proposal 2015-196.

Sen. Cataldo seconded.

Adopted.

Sen. Reagan left the meeting at this time, and Rep. Schmidt became Acting Chair.

8. The Committee discussed Final Proposal 2016-13 from the Department of Agriculture, Markets and Food (Poultry).

Rep. Hatch moved that the Committee approve Final Proposal 2016-13 with the understanding that the Department is prohibited by RSA 541-A:22, I from enforcing expired rules such as Agr 1600 in Final Proposal 2016-13 and that it must adopt expired rules again as swiftly as possible.

Adopted.

9. The Committee discussed Final Proposal 2016-20 from the Lottery Commission (Racing and Charitable Gaming Division, Bingo – Merger to Lottery). Valerie King testified for the Commission.

Sen. Reagan returned to the meeting during the discussion of this item.

Rep. Hatch moved that the Committee approve Final Proposal 2016-20.

Rep. Kidder seconded.

Adopted.

Sen. Reagan as Vice-Chair assumed the role of Acting Chair again at this time.

10. The Committee discussed Final Proposal 2016-21 from the Lottery Commission (Racing and Charitable Gaming Commission, Lucky 7 – Merger to Lottery). Valerie King testified for The Commission.

Rep. Schmidt moved that the Committee approve Final Proposal 2016-21.

Sen. Feltes seconded.

Adopted.

11. The Committee discussed Final Proposal 2016-22 from the Lottery Commission (Racing and Charitable Gaming Division, Games of Change – Merger to Lottery). Valerie King testified for the Commission.

Sen. Daniels seconded.

12. The Committee discussed Proposed Expedited Revisions to Agency Forms EXRF 2016-5 from the Lottery Commission (Games of Chance Forms). Valerie King testified for the Commission.

Sen. Feltes moved that the Committee approve Proposed Expedited Revisions to Agency Forms EXRF 2016-5.

Adopted.

13. The Committee discussed Final Proposal 2016-4 from the Board of Medicine (Opioid Prescribing Rules). Sarah Blodgett and Robert Lamberti from the Office of Professional Licensure and Certification testified for the Board.

Adopted. It was noted for the record that Sen. Daniels voted "no".

14. The Committee discussed the response by the Fish and Game Department to the Committee's preliminary objection on April 1, 2016 to Final Proposal 2015-206 (Limited Bobcat Season).
