APRIL 19, 2013

- (**) Part 1, Article 28-a of the N.H. Constitution was not an issue in the Committee's discussions or decisions in this meeting.
- 1. The meeting was convened at 9:05 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan, were Sens. Rausch and Cataldo, and Reps. Schmidt, McGuire, MacKay, Ladd, Kidder, Barry, Gottling, and Sad.

Sen. Reagan designated Rep. Barry as an alternate for Sen. Lasky, and Rep. Gottling as an alternate for Sen. Watters, who were absent.

2. The Committee discussed the minutes of the Committee meeting on March 15, 2013.

Sen. Rausch moved that the minutes be approved.

Sen. Cataldo seconded.

Adopted.

Rep. Schmidt seconded.

Adopted.

4. The Committee discussed the following Final Proposals for which the agencies had submitted requests for conditional approval (Consent Agenda – Conditional Approvals):

The Department had also submitted an amended conditional approval request dated April 18, 2013 for each of these Final Proposals.

It was the consensus of the Committee that discussion of these Final Proposals be postponed to later in the meeting.

5. The Committee discussed whether to postpone action on certain items to another meeting.

No action to postpone to another meeting was taken at this time.

6. The Committee discussed Final Proposal 2012-202 from the Department of Employment Security (Employer Requirements, Quarterly Reports, Authorized Agents, and Filing Requirements). Marie Bailinson and Gary Wright testified for the Department.

It was the consensus of the Committee to postpone action on this item to the next Committee meeting.

7. The Committee discussed Final Proposal 2012-132 from the Public Utilities Commission (Rules for Gas Service). Commissioner Michael Harrington and Commission staff Lynn Fabrizio and Randall Knepper testified for the Commission.

The Commission had submitted a request for conditional approval in a letter dated April 15, 2013 and amended rule dated April 12, 2013, and an amended request for conditional approval in an amended rule dated April 19, 2013.

Sen. Watters arrived during the discussion of this item. Rep. Gottling was therefore no longer a voting member.

Rep. Schmidt moved that the Committee accept the amended conditional approval request and conditionally approve Final Proposal 2012-132 based on the request, and recommend that the Commission approach the policy committees to see whether a clarification is necessary to the Commission's authority to regulate landfill gas.

Rep. McGuire seconded.

Adopted.

8. The Committee discussed Final Proposal 2012-146 from the Department of Safety (Nonresident Pistol/Revolver License Rules). Marta Modigliani testified for the Department.

Petty Dean also testified.

Rep. Schmidt moved that the Committee conditionally approve Final Proposal 2012-146 on the grounds that Saf-C 2100 be amended to replace "permit" with "license" and that Saf-C 2102.02(a)(4) be amended to replace "out of state" with "resident".

Sen. Rausch seconded.

Adopted.

Sen. Reagan noted for the record that there were two "no" votes.

9. The Committee discussed Final Proposal 2012-148 from the Passenger Tramway Safety Board (Various Passenger Tramway Safety Rules).

Sen. Rausch moved that the Committee postpone action on this item to the continued Committee meeting on May 3, 2013.

Rep. Schmidt seconded.

Adopted.

10. The Committee discussed again Final Proposal 2012-146 from the Department of Safety (Nonresident Pistol/Revolver License Rules).

Penny Dean of Concord, N.H. testified.

Sen. Rausch moved that the Committee reconsider its prior vote to conditionally approve Final Proposal 2012-146.

Rep. Schmidt seconded.

By a show of hands, there were 7 "yes" votes. The motion was adopted.

Pursuant to Committee rule 302.03(b), the effect of adopting the motion to reconsider was to cancel the prior vote to conditionally approve Final Proposal 2012-146 as if it had never been taken.

Penny Dean testified again in opposition to the rules, and then Jay E. Simkin of Nashua, N.H. also testified in opposition.

Scott Wallace of Merrimack, N.H. registered his opposition to the rules but chose not to speak.

Rep. McGuire moved that the Committee make a preliminary objection to Final Proposal 2012-146 on the grounds as outlined in public testimony, and the issues in the Committee's discussion, including that the age limit in Saf-C 2103.01(b)(5) was beyond the Department's authority and that Saf-C 2102 was unclear relative to the references on Form DSSP 260 to Vermont residents because the rule contained no requirements regarding Vermont residents.

Sen. Cataldo seconded.

Adopted.

Sen. Reagan noted for the record that there were two "no" votes.

11. The Committee discussed Final Proposal 2012-139 from the Board of Education (Nonpublic Schools). Mary Mayo of the Department of Education testified for the Board.

The Board had submitted a request for conditional approval in an amended rule received on April 18, 2013 and an amended request for conditional approval in a further amended rule received on April 20, 2013.

Sen. Cataldo left the meeting during the discussion of this item.

Rep. Ladd moved that the Committee conditionally approve Final Proposal 2012-139 based on the conditional approval request, the amended conditional approval request, and on the condition that the following further amendments be made:

- A new paragraph (a) should be inserted in Ed 405.01 to read: "Pursuant to RSA 193-E:3-b, I(c) NEASC shall be a recognized accrediting agency".
- The words "Accrediting agencies" in the existing Ed 405.01(a) should be amended to read "Other accrediting agencies that want".
- The existing Ed 405.01(a)-(k) should be editorially re-lettered as (b)-(1), and all cross-references in the proposal to the paragraphs of Ed 405.01 should be editorially corrected.

Sen. Watters seconded.

Adopted.

Sen. Reagan noted for the record that there was one "no" vote.

12. The Committee discussed Final Proposal 2012-155 from the Board of Education (Daily Physical Activity Program, Suspension and Expulsion of Students, and High School Equivalency Programs). Mary Mayo of the Department of Education testified for the Board.

The Board had submitted a request for conditional approval in an amended rule received on April 18, 2013.

Gerald M. Zelin, representing the N.H. Council of School Attorneys, also testified.

Rep. MacKay moved that the Committee accept the conditional approval request and conditionally approve Final Proposal 2012-155 based on the request.

Sen. Rausch seconded.

Rep. McGuire moved that the conditional approval also be based on the condition that Ed 310.02(a) and (b) be deleted and that Ed 310.03(b) be amended by deleting the words "child obesity."

Rep. Ladd seconded.

The motion as amended was adopted.

Sen. Reagan noted for the record that there was one "no" vote.

13. The Committee discussed Final Proposal 2012-170 (Application for Certification and Credential Renewal and Validity). Mary Mayo of the Department of Education testified for the Board.

The Board had submitted a request for conditional approval in an amended rule received on April 18, 2013.

Sen. Rausch moved that the Committee accept the conditional approval request and conditionally approve Final Proposal 2012-170 based on the request.

Rep. Sad seconded.

Adopted.
