- 1. The meeting was convened at 9:05 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan were Sens. Avard and French and Reps. McGuire, Schmidt, Ladd, Hatch, Ebel, Gottling, Matthews, and Ohm.
