- 1. The meeting was convened at 9:01 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan, were Sens. Rausch and Cataldo, and Reps. Schmidt, MacKay, Ladd, Sad, Kidder, Gottling, and Hatch.
