On a motion by Senator Rosenwald, seconded by Senator Bradley, that the Committee approve the request of the Department of Health and Human Services through March 31, 2025 to; 1) amend FIS 21-379, approved December 17, 2021 and subsequently amended (FIS 23-030) January 27, 2023 and (FIS 23-167) on May 19, 2023, to reallocate \$16,088,067 in federal funds, and 2) accept and expend \$33,746,013 in federal funds.
