#### INFORMATIONAL MATERIALS:

Jared Chicoine, Director, Office of Strategic Initiatives, responded to questions of Senator Kahn regarding FIS 20-171 Office of Strategic Initiatives – RSA 21-P:43, RSA 4:45, RSA 4:47, and Executive Order 2020-04, as extended by Executive Orders 2020-05, 2020-08, 2020-09, 2020-10, 2020-14, 2020-15 and 2020-16, Governor Sununu has authorized the Office of Strategic Initiatives (OSI) to; 1) accept and expend \$13,907,239 in federal funds from the Coronavirus Aid, Relief, and Economic Security (CARES) Act for the purpose of administering the Governor's Emergency Relief Funds to improve broadband infrastructure, effective from the date of the Governor's approval through December 31, 2020 and 2) authorization to enter into grant agreements with various vendors, for a total amount not to exceed \$13,907,239 to complete

their scope of services required for improvements to New Hampshire's broadband and internet infrastructure, effective upon your approval through December 30, 2020.

At Senator Rosenwald's request, Lori Shibinette, Commissioner, Kerrin Rounds, Chief Financial Officer, and Christine Santaniello, Director, Division of Economic and Housing Stability, Department of Health and Human Services, responded to questions of the Committee regarding FIS 20-181 Department of Health and Human Services — Operating Statistics Dashboard SFY21 report through July 31, 2020.

Senator Rosenwald requested clarification from the Department on the drop in caseload numbers for the Early Supports and Services, and also requested the lapse amount total for the Bureau of Elderly and Adult Services.
