### CONSENT CALENDAR REPORTS

#### COMMERCE

**SB 21**, relative to the due date and delivery of monthly reports and fees to the liquor commission. Ought to Pass, Vote 5-0.

Senator Gannon for the committee.

At the request of the New Hampshire Liquor Commission, this bill would change the report filing deadline for brewers and microbrewers from the 10th to the 15th of each month. This change would be in alignment with other reporting deadlines. Also, this bill would allow entities to file their reports electronically, which is not currently permitted.

**SB 23**, establishing a study committee on meat processing. Ought to Pass with Amendment, Vote 5-0.

Senator Innis for the committee.

In New Hampshire, small farms have consistently faced difficulties in processing animal meat in a timely manner. This bill would create a study committee to find ways to make existing processes more efficient. The Committee Amendment acknowledged that a state meat inspection program does exist, and discussion of that program and its limitations were held with the Department of Agriculture.

**SB 31**, relative to technical changes to the laws administered by the insurance department. Ought to Pass, Vote 5-0.

Senator Soucy for the committee.

At the request of the Insurance Department, this bill would make various technical changes to insurance-related statutes. First, Third Party Administrators would be allowed to post a bond, even if they are unable to meet the requirements for net worth or audited financial statements. Second, RSA 412:6 would be modernized while continuing to prohibit an insurer from requiring the payment of a judgement prior to coverage being provided. Third, RSA 415-C:3 would require insurers selling consumer guaranty contracts to register with the Department. Fourth, an inaccurate statutory reference would be removed from RSA 420-J:5. Finally, RSA 420-N would clarify that the Public Health Service Act is under the regulatory authority of the Department.

SB 37, establishing a commission to study hospitality and tourism education in New Hampshire. Ought to Pass with Amendment, Vote 5-0. Senator Innis for the committee.

The tourism and hospitality management industries are vitally important to New Hampshire's economy; however, they continue to face a myriad of problems. This bill would create a study commission designed to examine the supply and demand of these industries and how their future staffing and management talent needs can be met. The Committee Amendment changed the House membership from 3 to 5. Also, it added a representative from the Community College System of New Hampshire, the University System of New Hampshire, and a Career and Technical Education Center as members. Finally, an additional section was added to clarify that the commission shall be administratively attached to the Division of Travel and Tourism.

### **EDUCATION**

SB 24, relative to conferring degree-granting authority to the New England Aeronautical Institute.

Ought to Pass, Vote 5-0.

Senator Fenton for the committee.

SB 24 authorizes the New England Aeronautical Institute to confer degrees. Granting this authority is in compliance with the Department of Education's standard processes and has been done in recent years for other specialized academic institutions.

SB 25, repealing a requirement for a report on chartered public school payments.

Ought to Pass, Vote 5-0.

Senator Prentiss for the committee.

SB 25 repeals a Department of Education reporting requirement on payments made in a fiscal year to a chartered public school. This repeal was considered appropriate by the Committee because all information included in said reports is already publicly available data on or before October 1<sup>st</sup> of each year. Further, a previous bill from a previous General Court has negated the Department's need to request additional funds from the Fiscal Committee, making these annual reports obsolete.

**SB 39-FN**, relative to criminal history checks for school transportation monitors.

Ought to Pass, Vote 5-0.

Senator Lang for the committee.

SB 39-FN requires transportation monitors to undergo criminal background checks before being employed by public schools. This is seeking to close an inadvertent gap in child safety created by a bill from 2020 which assumed transportation monitors fell under the purview of the Division of Motor Vehicles. Upon review, the Department of Education and DMV realized that transportation monitors are not under the DMV's purview and should be reviewed by the Department for compliance with RSA 189:13-a, V.

### **JUDICIARY**

SB 27, relative to financial disclosure forms filed by judges.

Ought to Pass, Vote 5-0.

Senator Gannon for the committee.

SB 27 provides that the filing of a financial disclosure form by a judge pursuant to the New Hampshire Code of judicial conduct satisfies the requirement for filing a statement of financial interest. The language in this bill tracks with the language for legislative disclosure forms filed by legislators. The change will eliminate existing confusion to when judges need to file statements of financial interest.

**SB 29**, relative to repealing the statute relating to police matrons.

Ought to Pass, Vote 5-0.

Senator Carson for the committee.

SB 29 repeals the statute relating to police matrons. This antiquated statute has been in existence since 1915 and it should be removed from New Hampshire law.
