# CONSENT CALENDAR REPORTS

#### EXECUTIVE DEPARTMENTS AND ADMINISTRATION

SB 42-FN, relative to overpayment of unemployment compensation.

Ought to Pass, Vote 5-0.

Senator Carson for the committee.

This bill provides that the state shall not charge interest on the collection of an overpayment of unemployment compensation unless the person knowingly or willfully made a false statement in their application for benefits.

SB 45, relative to national guard educational benefits.

Ought to Pass, Vote 5-0.

Senator Carson for the committee.

This bill allows eligible national guard members to transfer their national guard tuition waiver benefit to their spouse to be used in a degree-enhancing curriculum in the university system of New Hampshire.

SB 57-FN, relative to the reduction in the calculation of state retirement annuities at age 65.

Ought to Pass, Vote 5-0.

Senator Perkins Kwoka for the committee.

SB 57-FN makes a simple change in statute to adjust Group I retirement benefits based on the achievement of full retirement age under the federal Social Security program. The federal Social Security program has set the retirement age at 67, and now New Hampshire retirees have been hit with a 10% penalty upon retirement at age that was originally intended to balance new Social Security income being received, which they are not eligible for two more years. This change will allow New Hampshire retirees to line the 10% penalty up with the beginning of Social Security benefits.

#### **HEALTH AND HUMAN SERVICES**

**SB** 30, relative to membership of the New Hampshire council on developmental disabilities. Ought to Pass, Vote 5-0.

Senator Whitley for the committee.

SB 30 provides that the Council on Developmental Disabilities shall consist of at least 21 members and removes language regarding how vacancies are filled for an unexpired term. Because the Council is federally funded, there are federally-imposed stipulations on the composition of the Council. SB 30 will bring the Council in compliance with those federal rules, as well as provide clarity on members appointed to fill vacancies.

SB 34-FN, relative to the controlled drug prescription health and safety program.

Ought to Pass, Vote 5-0.

Senator Prentiss for the committee.

SB 34-FN makes various technical changes to the Controlled Drug Prescription Health and Safety Program and is a request of the Department of Health and Human Services. This is an effort to clean up accidental errors from legislation that moved the PDMP to the Department from OPLC. It will also allow the Department to report aggregate data at the county-level, which they currently do not have the authorization to do.

SB 35, relative to RSV vaccine administration.

Ought to Pass, Vote 5-0.

Senator Birdsell for the committee.

SB 35 authorizes pharmacists, pharmacy interns, and licensed advanced pharmacy technicians to administer an RSV vaccine to adults. This is a standard process that the General Court has gone through as new vaccines emerge in an effort to expand the network of availability for vaccines. RSV is a serious illness and expanding access to vaccinations, once FDA and CDC approval have been granted, will be important in creating a healthy population in New Hampshire.

#### Amendment to SB 47

Amend RSA 12-O:58-a, I as inserted by section 1 of the bill by replacing it with the following:

- I. There is established a commission to study barriers to increased density of residential development in New Hampshire. The membership of the commission shall be as follows:
- (a) Two members of the senate, one of whom shall serve on the election law and municipal affairs committee and one of whom shall serve on the energy and natural resources committee, appointed by the senate president.
- (b) Six members of the house of representatives, 2 of whom shall serve on the municipal and county government committee and 2 of whom shall serve on the environment and agriculture committee, appointed by the speaker of the house of representatives.

- (c) The commissioner of the department of business and economic affairs, or designee.
- (d) The commissioner of the department of environmental services, or designee.
- (e) The executive director of the New Hampshire housing finance authority, or designee.
- (f) One representative of the New Hampshire Municipal Association, appointed by the association.
- (g) Two persons to represent builder, realtor, and business interests, chosen jointly by the New Hampshire Home Builders Association, the New Hampshire Association of Realtors, and the New Hampshire Business and Industry Association.
- (h) One person to represent planning interests, chosen jointly by the New Hampshire Planners Association and the New Hampshire Association of Regional Planning Commissions.
- (i) One person to represent conservation interests, chosen jointly by the Society for the Protection of New Hampshire Forests, the Nature Conservancy, and the New Hampshire Association of Conservation Commissions.
