

# CONSENT CALENDAR REPORTS

#### **EDUCATION**

**HB 446**, relative to participation in the education freedom accounts program by students with disabilities. Ought to Pass, Vote 5-0.

Senator Prentiss for the committee.

House Bill 446 amends RSA 191-F:4 III and requires the Bureau of Special Education Support within the Department of Education to notify parents of the rights and services available to their child with a disability. HB 446 is specifically meant to clarify what federal and state regulations applied for a child with a disability placed in the EFA program.

HB 464-FN, relative to eligible students in the education freedom account program.

Inexpedient to Legislate, Vote 5-0.

Senator Fenton for the committee.

House Bill 464 sought to expand access to the EFA program by including several additional groups whose eligibility would not be determined by income. Under HB 464, any child who was; in foster care, migratory, homeless, disabled, persistently bullied, learning English as a second language, received free or reduced meals, came from a persistently dangerous school, or came from a military family, would be eligible for the EFA program regardless of household income.

#### EXECUTIVE DEPARTMENTS AND ADMINISTRATION

HB 421, requiring menstrual hygiene products to be provided to prisoners who menstruate in state and county correctional facilities.

Ought to Pass with Amendment, Vote 5-0.

Senator Carson for the committee.

HB 421 as amended by the House requires that feminine hygiene products must be provided at no cost to all women in the custody of the state or the county. The amendment adopted by the committee simply adopt the language from SB 209 that was unanimously passed by the Senate earlier in the session. This includes the amendment which adds juvenile detention facilities and specifies sufficiency in regard to the number of menstrual hygiene products to be provided per menstrual cycle.

**HB 454**, relative to the membership and reporting responsibilities of the examining board of medicine. Inexpedient to Legislate, Vote 5-0.

Senator Altschiller for the committee.

HB 454 seeks to change the membership of the board of medicine adding members with no medical training, education, or background. It also adds a new position of a public transparency advocate. It is the opinion of the committee that this bill is too broad and gives the transparency advocate, who would be a public member of the board, unilateral authority to disclose any public or non-public information discussed by the board of medicine.

#### **HEALTH AND HUMAN SERVICES**

**HB 108**, relative to the confidentiality of reports made to the division of children, youth, and families and requiring guardians ad litem be appointed in certain instances.

Re-refer to Committee, Vote 5-0.

Senator Avard for the committee.

HB 108 provides that reports of suspected abuse and neglect may include the name of the person making the report and provides that the person's identity shall be fully confidential unless such a person makes such a report in bad faith or maliciously and with intent to cause harm, in which case the person may be subject to civil and criminal penalties. The Committee felt it did not have appropriate time or resources to consider the potential implications of this legislation. Rereferring HB 108 will give the Committee time for those considerations.

HB 408, relative to foster children and vaccinations.

Ought to Pass with Amendment, Vote 5-0.

Senator Avard for the committee.

HB 408 requires that children living in a foster family home, but who are not in foster care, shall be subject to the same immunization requirements as any other child in the state. The Committee Amendment represents an agreement with the Department of Health and Human Services and the prime sponsor to level the playing field for all children across the state and ensure the same standards apply regardless of a child's foster care status. The Committee Amendment also ensures that federal funding opportunities will not be put at risk by directing the Department to seek a waiver before implementing an expansion of the exemptions available to a child.

#### **JUDICIARY**

**HB 68-FN**, adopting the uniform real property transfer on death act.

Re-refer to Committee, Vote 5-0.

Senator Carson for the committee.

House Bill 68-FN adopts the uniform real property transfer on death act. This bill is designed to allow people to transfer real estate at death without having to go through the expense of having a will. While the Committee thought there was a lot of merit to the bill, it needs more work before final consideration.

HB 321-FN-L, relative to minutes from nonpublic sessions under the right to know law.

Ought to Pass with Amendment, Vote 5-0.

Senator Chandley for the committee.

House Bill 321-FN-L requires public bodies to review meeting minutes withheld from public disclosure at least every 10 years to determine whether they should continue to be withheld. Minutes not reviewed after 10 years shall be made public. The Committee Amendment makes no substantive change to the bill; it simply changes the format to enhance clarity. This bill ensures that nonpublic meeting minutes will be routinely assessed and released furthering government transparency in this state.

**HB 376**, establishing a committee to study the current education, training, and requirements for personnel employed as emergency dispatchers and 911 telecommunicators for police, fire, and emergency medical organizations. Ought to Pass, Vote 5-0.

Senator Whitley for the committee.

House Bill 376 establishes a committee to study the current education, training, and requirements for personnel employed as emergency dispatchers and 911 telecommunicators for police, fire, and emergency medical organizations. There is no standardized course for training and there are significant differences between training at the municipal level and at the state level. This committee will be tasked with making recommendations regarding uniformity in training requirements and formal certification standards based on state or national standards.

**HB 379-FN**, requiring notice be provided to tenants during residential eviction proceedings regarding legal counsel. Re-refer to Committee, Vote 5-0.

Senator Ward for the committee.

House Bill 379 provides that tenants subject to eviction shall be provided with instructions on the process for contacting and obtaining assistance from New Hampshire Legal Assistance. Numerous concerns were raised at the public hearing; therefore, the Committee felt that Re-Referring the bill would provide stakeholders with additional time to reach an agreement.

**HB 517**, relative to background checks for surrogate parents.

Ought to Pass, Vote 5-0.

Senator Chandley for the committee.

House Bill 517 would require an educational surrogate for special education to undergo a criminal history records check. While the Department's administrative rules do require a background check, there is not currently the enabling language in law. The Department of Education requested this legislation to ensure that the requirement for background checks and the disqualifying offenses would be codified in statute.

Senate Judiciary May 9, 2023 2023-1729s 05/08

#### Amendment to HB 321-FN-LOCAL

Amend the bill by replacing section 1 with the following:

- 1 New Paragraph; Minutes from Nonpublic Session. Amend RSA 91-A:3 by inserting after paragraph III the following new paragraph:
- IV.(a) A public body or agency may adopt procedures to review minutes of meetings held in nonpublic session and to determine by majority vote whether the circumstances that justified keeping meeting minutes from the public under RSA 91-A:3, III no longer apply. If the public body determines that those circumstances no longer apply, the minutes shall be available for release to the public pursuant to this chapter.
- (b) In the absence of an adopted procedure to review and determine whether the circumstances no longer apply for meeting minutes kept from the public, the public body or agency shall review and determine by majority vote whether the circumstances that justified keeping meeting minutes from the public under RSA 91-A:3, III no longer apply. This review shall occur no more than 10 years from the last time the public body voted to prevent the minutes from being subject to public disclosure. Meeting minutes that were kept from the public prior to the effective date of this paragraph that are not reviewed by the public body or agency within 10 years of the effective date of this paragraph shall be subject to public disclosure without further action of the public body.

Health and Human Services May 10, 2023 2023-1745s 07/05

#### Amendment to HB 408

Amend the bill by replacing all after the enacting clause with the following:

- 1 New Section; Residential Care and Child-Placing Agency Licensing; Immunization Requirements for Foster Family Homes. Amend RSA 170-E by inserting after section 27-a the following new section:
- 170-E:27-b Immunization Requirements for Foster Family Homes. There shall be no vaccination or immunization requirements required of any children residing in a foster home that exceed vaccination or immunization requirements under RSA 141-C:20-a, either in type of vaccination or quantity of doses.
- 2 Department of Health and Human Services; Foster Care and Child Vaccination or Immunization Exemptions; Waiver Request. On or before October 1, 2023, the department of health and human services shall submit a waiver request to the Administration for Children & Families seeking approval for all children who are foster family household members, regardless of age, residing in a foster household to claim any exemption from a vaccination or immunization requirement under RSA 141-C:20-c.
  - 3 Effective Date. This act shall take effect upon its passage.

#### AMENDED ANALYSIS

This bill requires that children living in a foster family home shall be subject to the same immunization requirements as any other child in the state and mandates the department of health and human services seek a federal waiver to allow those children to claim any immunization exemption available to children under state law.

#### Amendment to HB 421

Amend the title of the bill by replacing it with the following:

AN ACT relative to providing menstrual hygiene products at no cost to individuals who biologically menstruate in state and county correctional facilities.

Amend the bill by replacing all after the enacting clause with the following:

1 New Subdivision; County Departments of Correction; Care and Custody of Individuals Who Biologically Menstruate. Amend RSA 30-B by inserting after section 26 the following new subdivision:

Care and Custody of Individuals Who Biologically Menstruate

30-B:27 Provision of Menstrual Hygiene Products. The superintendent of each county correctional facility shall provide sufficient menstrual hygiene products to individuals who are in the custody of the county who biologically menstruate, at no cost to such persons. Sufficiency shall be considered, at minimum, a combination of 20 standard issue menstrual hygiene products per individual's menstrual cycle. An individual may request additional menstrual hygiene products based exclusively on their cycle at no cost at the discretion of the superintendent. The number of menstrual hygiene products kept in a cell shall not be excessive so as not to create safety or security issues and shall only be used for the intended purpose. As used in this section, "menstrual hygiene products" means tampons, menstrual pads, sanitary napkins, and pantiliner.

2 New Section; Care and Custody of Female Convicts; Provision of Menstrual Hygiene Products. Amend RSA 622 by inserting after section 37 the following new section:

622:37-a Provision of Menstrual Hygiene Products. The warden or director of each state correctional facility and any facility listed in RSA 169-B:14, I(c) or (e) shall provide sufficient menstrual hygiene products to individuals who are in the custody of the state who biologically menstruate, at no cost to such persons. Sufficiency shall be considered, at minimum, a combination of 20 standard issue menstrual hygiene products per individual's menstrual cycle. An individual may request additional menstrual hygiene products based exclusively on their cycle at no cost at the discretion of the commissioner, or designee. The number of menstrual hygiene products kept in a cell shall not be excessive so as not to create safety or security issues and shall only be used for the intended purpose. As used in this section, "menstrual hygiene products" means tampons, menstrual pads, sanitary napkins, and pantiliners.

3 Effective Date. This act shall take effect August 1, 2023.

#### AMENDED ANALYSIS
