Proposed Compromise Amendment on Congressional Districts

The Governor's comments on WMUR's *Close Up* last week indicated he would be asking for changes to HB 52, the House-approved Congressional voting district proposal. In answer to those concerns, the Map-a-Thon team has created a compromise Congressional map which we have shared with the Governor's office and now with you. This map with proposed amendment text is attached as a PDF.

Unlike other proposals, this map has some distinct advantages:

- It is visually compact, clean-looking, and resembles the districts of the past
- With two exceptions, the districts are confined, or "nested," within county lines a redistricting best practice
- The exceptions: All of Hillsborough County is in District 2, except the city of Manchester and the town of Pelham in District 1.
- It moves only 12 towns vs. 75 for the current proposal
- Because the districts follow county lines, the Map-a-Thon's compromise does a superior job of following communities of interests such as breaking up far fewer regional high school districts, the number one voter-cited connection between towns.
- District 1 still leans Republican, and District 2 Democrat, but both are far more competitive than the proposed map
- Unlike the 2010 or House-approved map, the Map-a-Thon's proposal makes District 2 competitive enough to be within striking distance of Republican candidates
- Its deviation is only 43 people

We hope that you will give this map serious consideration, as it strikes a balance between the parties, and serves the voters with truly competitive districts.
